They are also given to understand that on their appointment to the Government Service on or after 1st November, 2005 they would be

covered under new "Define Contribution Pension Scheme" and the existing pension scheme i.e. Maharashtra Civil Services (Pension) Rules, 1982 and Maharashtra Civil Services (Commutation of Pension) Rules, 1984 and General Provident fund will not be applicable to them.
