B) The candidates whose name * (Starmark) is mentioned shall require to qualify ENGLISH typing test within a period of 1 year from the date of respective appointments.

C) The candidates whose name # (Hashmark) is mentioned shall require to qualify MARATHI typing test within a period of 1 year from the date of their respective appointments.

D) These candidates shall also give undertaking to the effect that their appointment is on ad-hoc basis and they will be discharged from service if they fail to clear the requisite test as stated in condition 'B & C' within a period of one year from the date of their respective appointment.
