**CIRCULAR**

1. In continuation of earlier Order No. 13588-13676/DJ/NK/DWK/2020 dated 29.08.2020 of the undersigned and as per the Order No. 71/DHC/Gaz/G-7/VI.E.2(a)/2020 dated 18.11.2020 of the Hon'ble High Court of Delhi having its immediate effect 10 new Digital Courts (NI Act) would start functioning from Dwarka Courts Complex and their newly created URL's are to be uploaded on the Website of Dwarka District Courts (SW). Accordingly, the list of the virtual courts of South West District published by Circular No. 20431-20516/DJ/NK/DWK/2020 dated 17.11.2020 on the Website of Dwarka District Courts (SW) stands modified/updated.
