

### NOTIFICATION

**Subject :** Due to prevailing situation of Covid-19, holding the Jail Courts on Video Conferencing to take up the cases of Under-trial Prisoners

**Reference :** 1. Letter No. A(Spl.)/Misc. /313/2009 dated 14.10.2009 from the Hon'ble High Court, Bombay.  
2. Letter No. A(Spl.)/Misc. /174/2014 dated 01.08.2014 from the Hon'ble High Court, Bombay.

In view of the above references, the following Judicial Officers are requested to attend the Daily Jail Court on Video Conferencing to take up the cases of those Under Trial Prisoners who are involved in Petty Offences punishable upto three years or are keen to confess their guilt, in order to reduce the pendency of cases of Under Trial Prisoners.

They shall attend Jail Court duty on Video Conferencing in First Session at **Thane Central Prison**. They are permitted to frame charge against accused, record statement of accused U/sec.313 of Cr. P.C. and also entertain and dispose of Bail applications of the accused.

The charge of the **Court** of Judicial Officer attending the Jail Court duty on Video Conferencing, in case the concerned Judicial Officer is on leave or otherwise absent on the date of Jail Court Duty assigned to him/her, the Judicial Officer holding the charge of his/her Court shall attend the **Jail Court Duty** on Video Conferencing on that day.


