  2. Due to prevailing situation of Covid-19, Judicial Officers are requested to attend Night Bail work on Video Conferencing.
  3. Police Officers are directed not to bring accused at the residence/quarters of Judicial Officers.

- 1 The above arrangement should be scrupulously noted by the Advocates and parties. They should not trouble any Magistrate or Chief Metropolitan Magistrate, Mumbai at their residence for inquiries about the Night Bail Postings.
- 2 The earlier Addl. Chief Metropolitan Magistrate / Metropolitan Magistrate, who were appointed for the Urgent Bail Applications are requested to hand over the Seal and Stamp etc. if any, to their successors.
- 3 The concerned Police Stations in Gr. Mumbai should depute their official along with the say in Bail Applications to appear before the concerned Magistrate at his/her residence. These directions should be followed scrupulously.
- 4 The concerned Judicial officer should make his/her own arrangement mutually with his/her colleague for this work during his leave period or while leaving the Headquarter.
- 5 The Concerned Judicial Officer while proceeding on leave or leaving the Head Quarter should specifically mention in his/her application for leave and application seeking permission to leave Head Quarter, the name of the Judicial Officer who will attend his/her duty in his/her absence.
