

ORDER

As per directions contained in order dated 29.04.2020, letter No. 18/Spl./RG/Misc. dated 08.05.2020 as well as order bearing Endst. No. 618-Spl.Genl./XVII.3(6-G) dated 23.05.2020 of the Hon'ble High Court of Punjab and Haryana, Chandigarh, the Subordinate Courts in the State of Punjab, Haryana and U.T. Chandigarh will function with the continuation of present arrangement of hearing of cases in view of prevailing situation arising due to outbreak of COVID-19. It is also ordered that the officials on duty shall remain present from 09:30 a.m. to 05:00 p.m. and any lapse in this regard shall be viewed seriously.


