It is for general information that as the existing panel of Para Legal Volunteers under the District Legal Services Authority (DLSA)-Jamui is going to expire on 13/04/2023, a fresh panel as per the NALSA - Scheme of Para Legal Volunteers is required to be prepared and the existing panel of Para Legal Volunteers under the DLSA- Jamui will be invalidated after engagement of new PLVs through fresh panel.

All the PLVs of existing panel may make fresh application for their engagement afresh.

The District Legal Services Authority, Jamui is going to induct/empanel 100 nos. of Para Legal Volunteers (PLVs) for Jamui District for a period of one year which may be extended further. As such, applications in prescribed form are invited from intending candidates of the following groups of people residing in Jamui District: -

Teachers (including retired teachers) / Retired Government servants and senior citizens / M.S.W Students and teachers / Anganwadi workers / Doctors / Physicians / Students & Law Students (till they enroll as lawyers) / Members of Non-Political, Service oriented NGOs and Clubs / Members of Women Neighbourhood Groups and other Self Help groups, Maithri Sanghams and other Self Help Groups including marginalized/vulnerable groups / Educated prisoners with good behaviour, serving long term sentences in prisons / Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

Note: Preference will be given to applicants who have residence/accommodation in the territorial jurisdiction of the following Blocks.

Eligibility for applicants:

He/ She must be a citizen of India.

He / She is not accused of any criminal case.

The minimum age for the selection of Para legal Volunteers should not be less than 18 years as on the date of advertisement.

The candidate should have minimum qualification of Matriculation (10th Standard) with a capacity for overall comprehension who do not look up to the income they derive from their services as PLVs and who have a mind set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalized people and weaker sections of the society and have inclination for social service.

Note: The work of PLVs does not carry any Salary, remuneration or wages except the honorarium as per existing Rules and Regulations of NALSA & BSLSA, Patna (honorarium at present Rs. 500/-per day). Further, the empanelment of any person as PLV does not entitle him for honorarium nor the authority is obliged to give him work after empanelment. The duties, function end remuneration of PLVs shall be governed by NALSA Scheme or Para Legal Volunteers and regulation in this regard from time to time.

Date and time for submission of application:

The filled up prescribed application along with self-attested copies of certificates in respect of age, qualification and proof of residence along with work experience, if any, should reach, either by post or personally, to the office of the District Legal Services Authority, Jamui by 20/03/2023 till 05:00 P.M. addressed to "The Chairman, District Legal Services Authority, Jamui". Method of Selection :-

Incomplete applications will be rejected without assigning any reason. The selection of Para Legal Volunteers shall be made by the Selection / Recruitment Committee of DLSA, Jamui and the candidates shall be selected through an interview / personality test.

If it appears to the Authority that the number of applications are huge then a preliminary screening of the applications may be done to shortlist the number of candidates. The basis of screening elimination will be decided by the Selection Committee after getting the applications.

In case of any objection regarding enlistment of Para Legal Volunteers, the decision of the Selection / Recruitment Committee of DLSA, Jamui shall be final and binding on all concerned.

Canvassing directly or indirectly will disqualify the candidate.

In case, it is detected at any point of time in future, even after empanelment, that the candidate was not eligible, empanelment of the candidate shall be liable to termination forthwith.
