- ii) The officer conducting the sale shall decide by what amount the auction bids should be raised. Should there be any dispute regarding the amount of the auction-bid or the person who offered it, the lots in question shall be re-auctioned forthwith.

- iii) The highest bidder shall be declared to be the purchaser of any lot, provided always that he is legally qualified to bid, and provided that it shall be in the discretion of the Magistrate or the Officer conducting the sale to decline acceptance of the highest bid when the price offered appears so clearly inadequate as to make it advisable to do so.
- iv) The Officer conducting the sale may, if he finds it necessary, adjourn the sale recording the reasons for such adjournment.


