Applications are invited as per proforma from the eligible candidates having requisite qualification and experience as required under Rule-5 & 6 of the Family Courts (Orissa) Rules, 1990 for appointment of Counsellor in the Court of Judge, Family Court, Boudh.

1. ELIGIBILITY & QUALIFICATIONS OF COUNSELLOR:

- (a) be a Citizen of India.
- (b) have passed Master's Degree in (Social Science preferably in Sociology or Psychology).
- (c) have minimum experience of 3 years in family counseling.
- (d) be able to speak, read and write Odia and have passed test in Odia equivalent to the M.E. standard.
- (e) be of sound health and have not more than one spouse living.

Provided that where such persons are not available, persons above the age of thirty-five working in the field of social service and welfare activities and engaged in promoting the welfare of Family and Child Care with a degree in (Social Science preferably in Sociology or Psychology) shall be eligible for such appointment.

2. FUNCTIONS OF A COUNSELLOR:

The functions of a Counsellor shall be regulated in accordance with the terms and conditions laid down in the Family Courts (Orissa) Rules, 1990 and amendments made there under from time to time.

3. FEE OF A COUNSELLOR:

As per Rule-33 of Family Courts, (Orissa) Rule-1990, the counselor shall be entitled to assisting fees of Rs.788/- (Rupees Seven hundred and

eighty eight) only per day of actual working as per Law Department Resolution No.1693, dated 15.02.2019.

4. **DOCUMENTS REQUIRED:**

The following list of documents are to be submitted along with the application form:

- (i) Self attested Xerox copies of all the Educational Qualification certificates.
- (ii) Experience certificate in the field of family counseling, social service and welfare activities and engagement in promoting the welfare of Family and Child Care.
- (iii) Self attested two numbers of pass port size photographs.
- (iv) Matriculation Certificate in support of age proof.
