As such, applications from intending candidates viz. teachers (including retired teachers) , Retired Govt. servants and senior citizens, M.S.W students and teachers, Aganwadi workers, Doctors/ Physicians, Students and Law students (till they enrolled as lawyers), members of Non Political service oriented NGOs and Clubs, Members of women Neighborhood Groups, Maithri Sanghams and other Self Help Groups including marginalized/ vulnerable groups, Educated Prisoners with good behaviour serving long term sentences in prisons, etc. or others having a **minimum qualification of matriculation**, who do not look up to the income they derive from their services as PLV's and who have a mindset to assist the needy in the Society coupled with compassion, empathy and concern for the upliftment of the marginalized and the weakest section of the society.

It needs to be mentioned herein that work of PLV's do not carry any salary or remuneration except honorarium fixed by DLSA from time to time.

The applicants shall have to mention in their application their willingness to work and also the preference to work either at the district level, or village level.
