Applications are invited from eligible candidates to fill the following posts, as under:-

The number of vacancies may be increased or decreased due to creation or withdrawal of courts or otherwise during the selection process. No intimation in this regard will be issued separately.

The selection for the aforesaid posts shall be made strictly in accordance with amended Rule 7 of the Haryana Subordinate Courts Establishment (Recruitment & General Conditions of Service) Rules, 1997.

1. **Qualification:**

- The candidate should be at least middle pass with Punjabi/Hindi as one of the subject and
 - The candidate should possess a valid licence for L.T.V. and
 - The candidate should not have been convicted of any offence for negligent driving and should have a minimum of two years experience of driving a car.

Sweeper:- Candidate should have experience of the duties required to be performed by him/her. However, he/she should be able to sign in Hindi or Gurmukhi language as the case may be.

2. **AGE LIMIT (for all post):**

No person shall be recruited to the service, if he/she is less than 18 years or is more than 42 years of age as on 01.01.2021.

3. **LAST DATE:**

The Last date for receipt of the applications shall be **20.08.2021** upto **4:00 P.M.**. Applications received thereafter shall not be entertained in any case. Delay on the part of postal authorities shall not be a ground for entertaining the applications received after due date.

4. **Date and place of Interview:**

The date and schedule of viva-voce would be uploaded on the official website of this office i.e. **eCourts Faridabad**, in due course as and when approved by the Hon'ble High Court qua regular posts. The candidates are advised to visit the website regularly. No separate call letters for the viva-voce would be sent to the candidates.

5. **Separate applications for each post**, on plain paper with recent passport size photograph of candidate affixed thereon containing full particulars i.e. Name, Father's/Husband's Name, Date of Birth, Sex, Educational Qualification, Permanent address, present postal address, Nationality, Contact Number, E-mail Id, experience if any, along with attested copy of relevant certificates (copy of licence of L.T.V. for the post of driver only) should reach the office of the District and Sessions Judge, District Courts, Sector-12 Faridabad, either by registered post or by hand well before the closing date i.e. **20.08.2021 by 04:00 P.M.** **Applications received through e-mail shall not be entertained.**

The incomplete applications, such as without name of post applied for, date of birth, educational qualification, filed without photograph, without attested copies of relevant certificates, testimonials and received after due date or before the date of advertisement, shall be rejected out-rightly without any
