

It is brought to the notice of the General Public, that the open auction of the Public Utility Services i.e. Lawyers Canteen (2nd floor, Block-B), Shop No.2 for Petition Writers/Stamp vendors/typist and Shop No. 3 for PCO/STD/Photostat Service/computer service at New Judicial Court Complex, Ferozepur, for the year 2021-22 (w.e.f. 01.08.2021 to 31.03.2022) will be held on 26.07.2021 at 02:30 P.M. in the New Judicial Court Complex, Ferozepur.

The Successful bidder/lessee shall deposit 25% of the lease money at the time of auction and the balance amount of 75% of the lease money shall be deposited within one month of the commencement of lease period. In case of non deposit of the lease money within the prescribed time, the first deposit of 25% of the lease money shall be forfeited and the contracts will be put to auction for the remaining period. The first lessee shall be liable to pay the difference, if any, between the lease money, if the subsequent lease is for the lessor amount. The lessee shall also produce a surety who will execute a bond to the effect that he will be responsible to pay the lease money due to the Civil Judge (Sr. Divn.) Ferozepur, in case the lessee make default in paying the same.
