5. The quotations addressed to the undersigned in sealed cover should reach this office latest by 5 p.m. on or before 22.07.2019 by any mode. Quotations received within the stipulated date & time will be opened on 23.07.2019 at 5 p.m. in presence of bidders or their authorized agents, if any. The sale will be awarded in favour of the bidder who offers highest price. The undersigned will not be held responsible for submission of tender beyond the stipulated time.
6. The highest bidder, whose bid is accepted , shall have to deposit 25% of the bid amount immediately as initial deposit failing which EMD shall stand forfeited to the State. The bidder shall deposit rest 75% of the bid amount on or before 30.07.2019 along with GST as admissible.

7.The EMD deposited by the successful bidder will be adjusted at the time of final payment of bidding value.

8.The EMD deposited by the unsuccessful bidders will be returned within three weeks of the award of contract to successful party without any interest.

9.The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own risk & cost. This Office will not be responsible for any lapse on his part in this regard.

10. The vehicle sold shall have to be removed from the premises within 7 days from the date of deposit of the entire amount failing which ground rent @ 1% of the bid amount shall be chargeable per each day.
