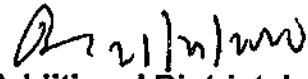

# HIGH COURT OF ANDHRA PRADESH : AMARAVATI

## CIRCULAR

Subj: Dispensing with Zoom Meeting Application in view of advisory issued by the Government of India, Ministry of Home Affairs, New Delhi, through CyCod (Cyber Coordination Centre) – **BlueJeans** Video Conferencing application tested and found to be an alternative for Zoom Meeting Application – Directions issued to use **'BlueJeans App'** for web hearing of cases in the High Court and Subordinate Courts in the State of Andhra Pradesh – Reg.

As notified earlier, during the lock-down period, the High Court has taken a decision to conduct the web hearing of cases of urgent in nature in the High Court and Subordinate Courts in the State of Andhra Pradesh through video conferencing.

Instructions have been issued to conduct the video conferencing through Zoom Meeting Application for conducting the web hearing of cases. On 13.4.2020, an advisory has been issued by the Ministry of Home Affairs, Government of India informing that the Zoom Meeting Application is unsafe and cannot be used in the Government Offices since it is vulnerable for malicious attacks and hacking.

In this regard, High Court has taken a decision to conduct the web hearing of cases through video conferencing by using **BlueJeans Meeting Application** and to dispense with usage of Zoom Meeting Application in the High Court and Subordinate Courts. Detailed procedure for downloading the **BlueJeans Meeting App** and joining the video conference through **BlueJeans Meeting Application** is attached hereunder.

Therefore, all the Learned Advocates and parties-in-person are requested to download the **BlueJeans Meeting Application** in their desktops/laptops/i-pads/mobiles etc., for web hearing of cases in the High Court and Subordinate Courts through video conferencing from tomorrow i.e., 21.4.2020 onwards. The meeting I.D. will be shared by the High Court before commencement of the Court proceedings.

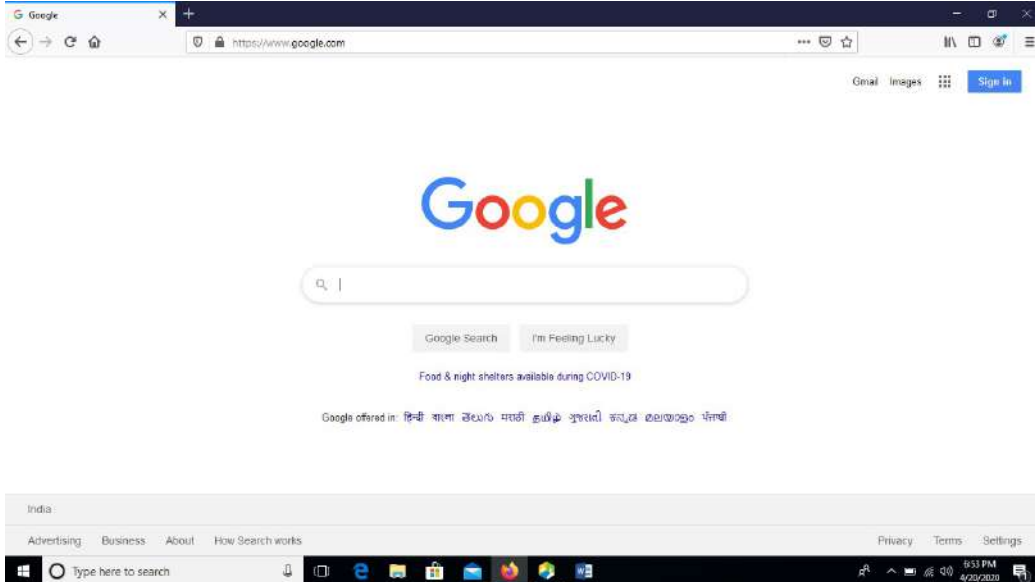

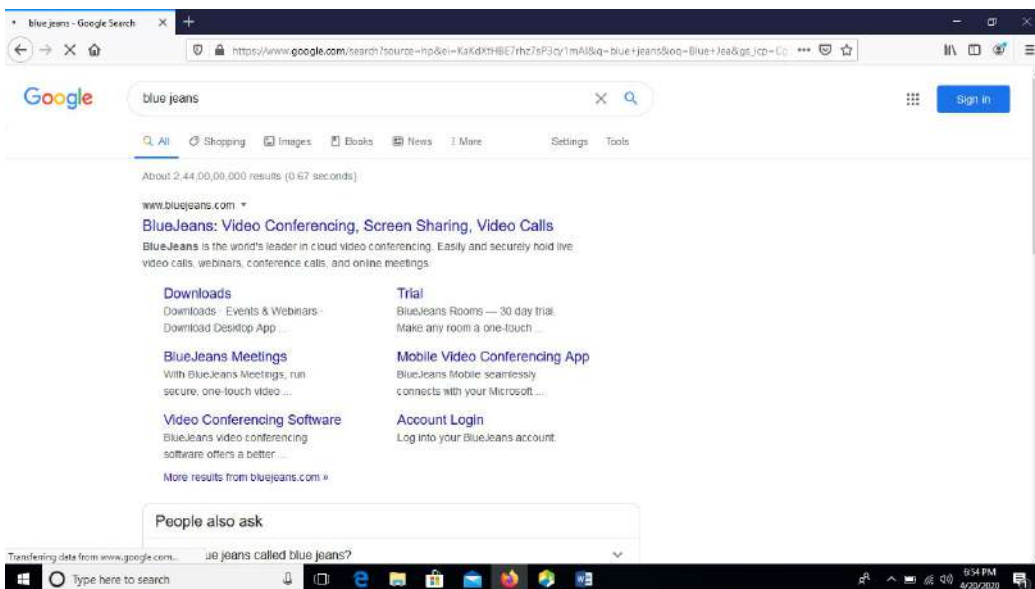

## 1. Go to Google

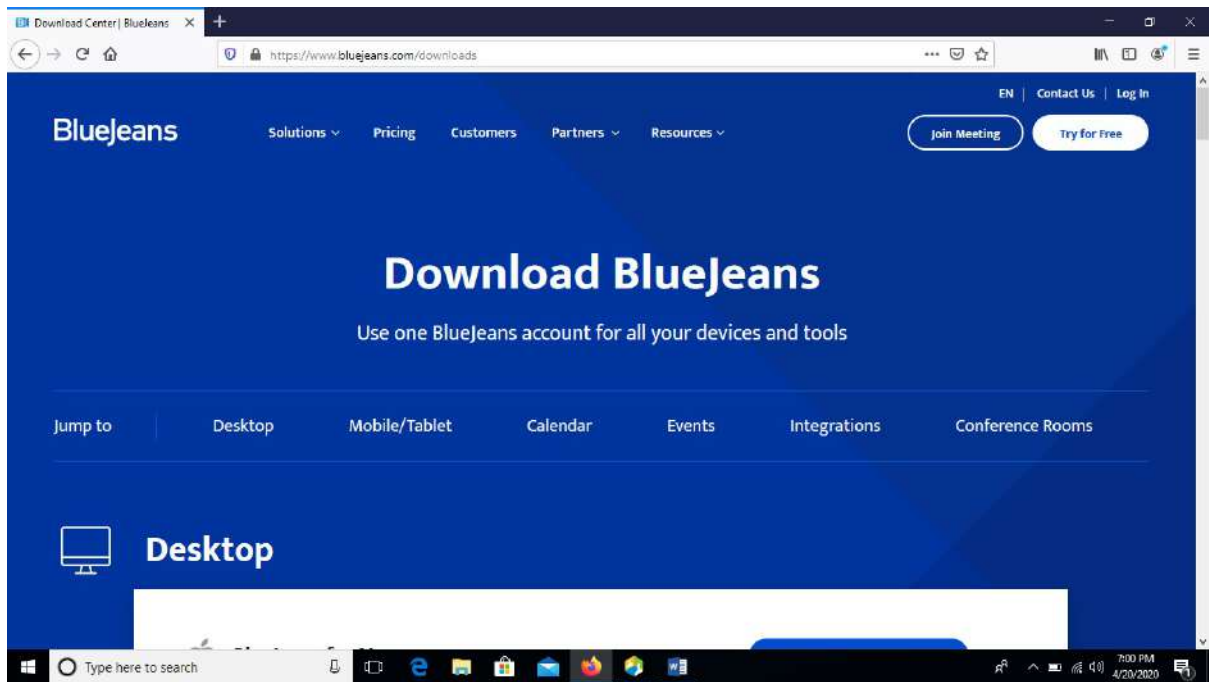


## 2. Type Blue Jeans in Google

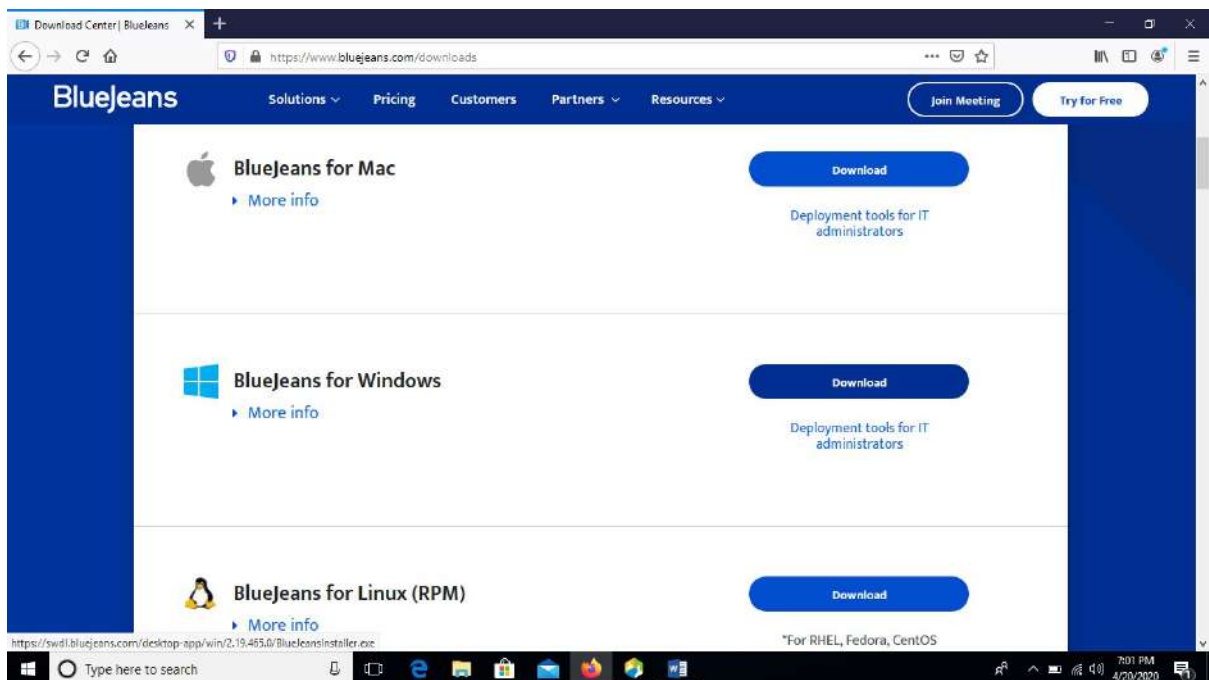


## 3. Select Downloads option

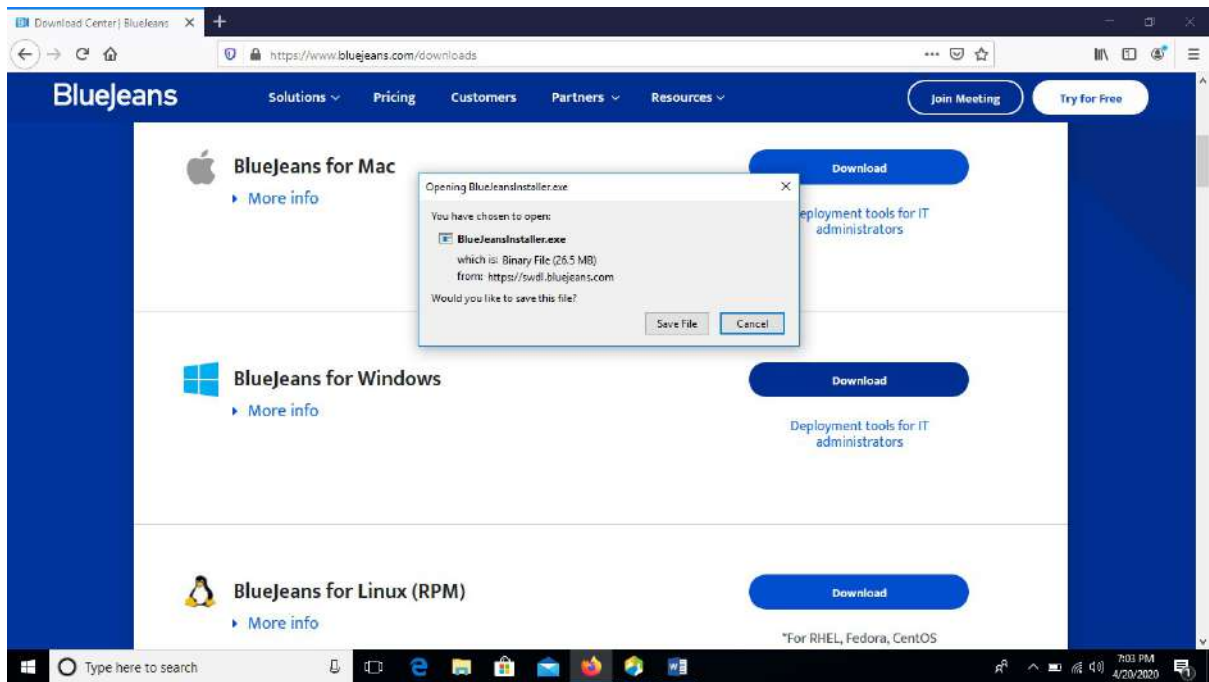
## 4. Scroll down to find the Operating System you are using.



5. If you are using Windows click on download against the Windows button

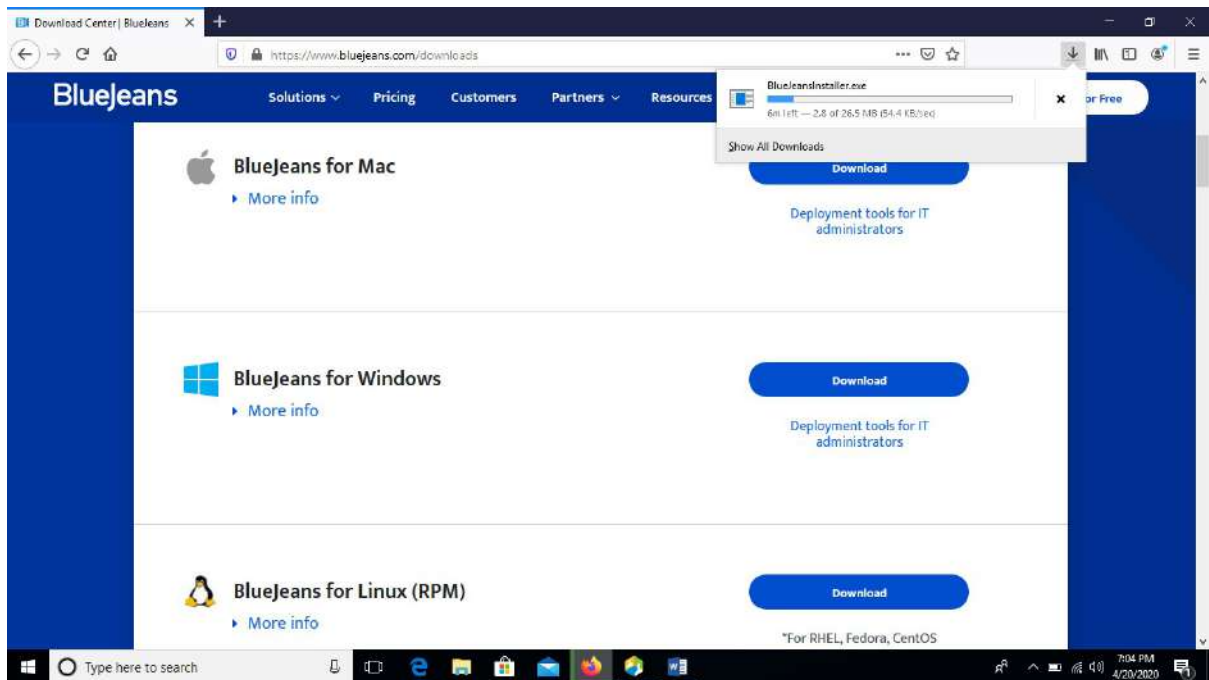


6. If you click the download the next screen is as below:



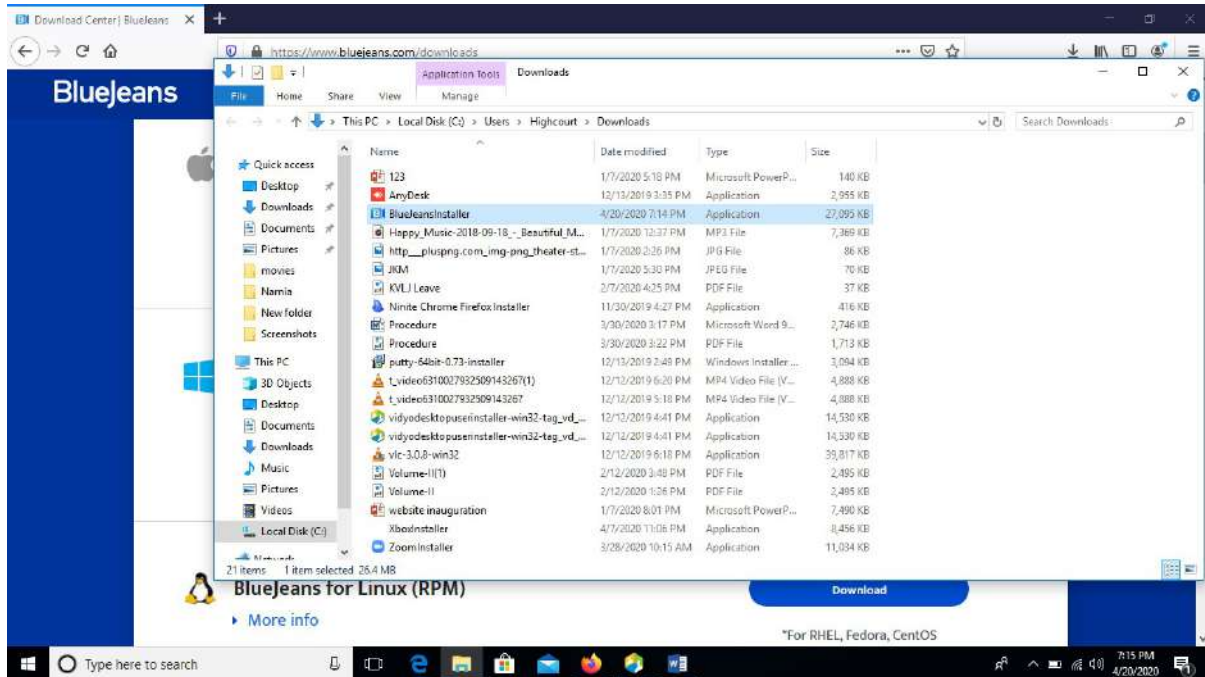
7. Click on Savefile option

8. Then the exe file will download

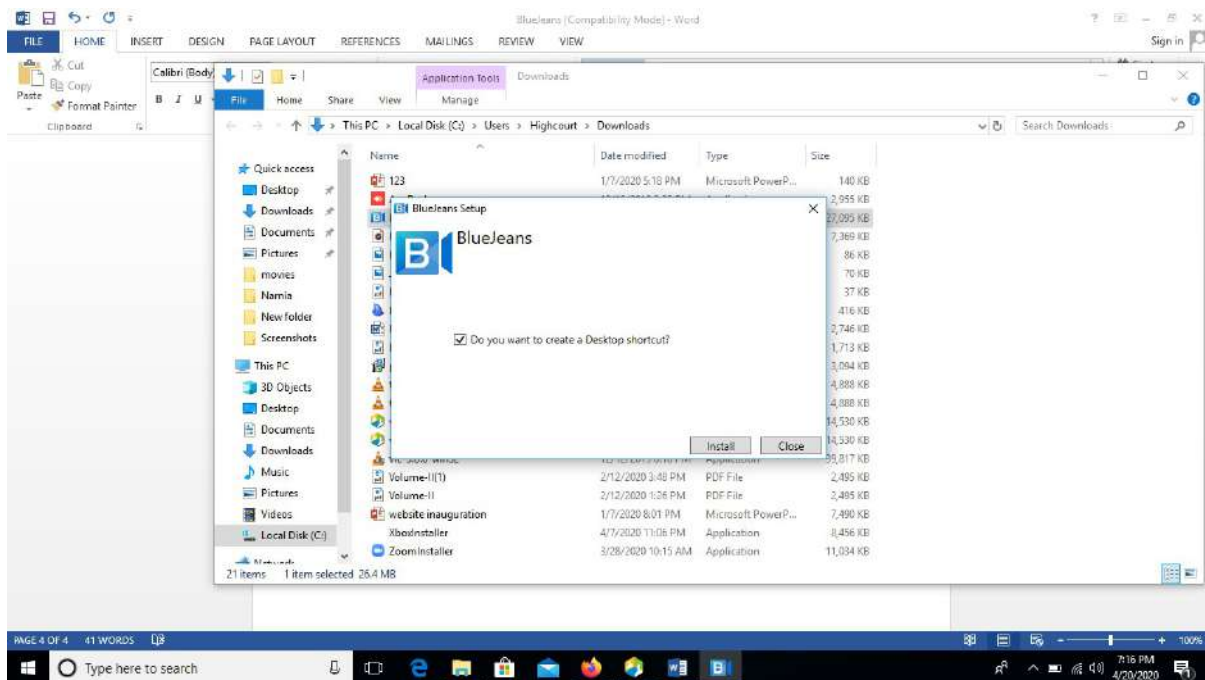




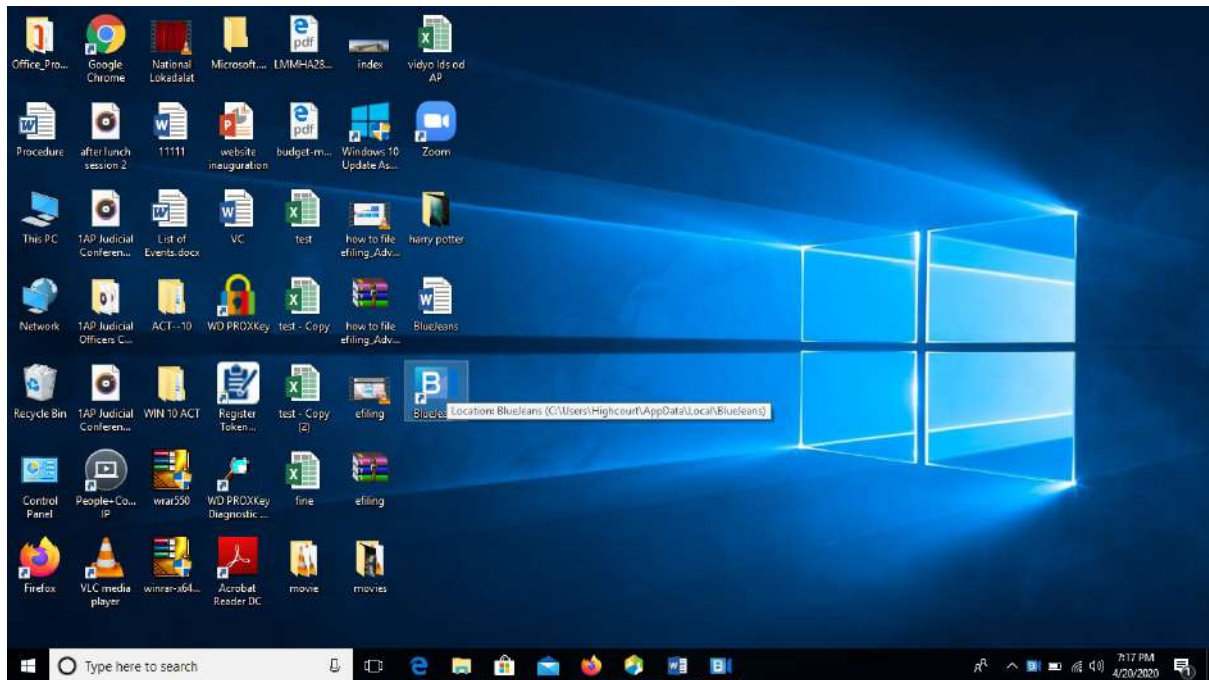
9. Please check the downloads in your Computer System to find the exe file  
“Bluejeansinstaller”



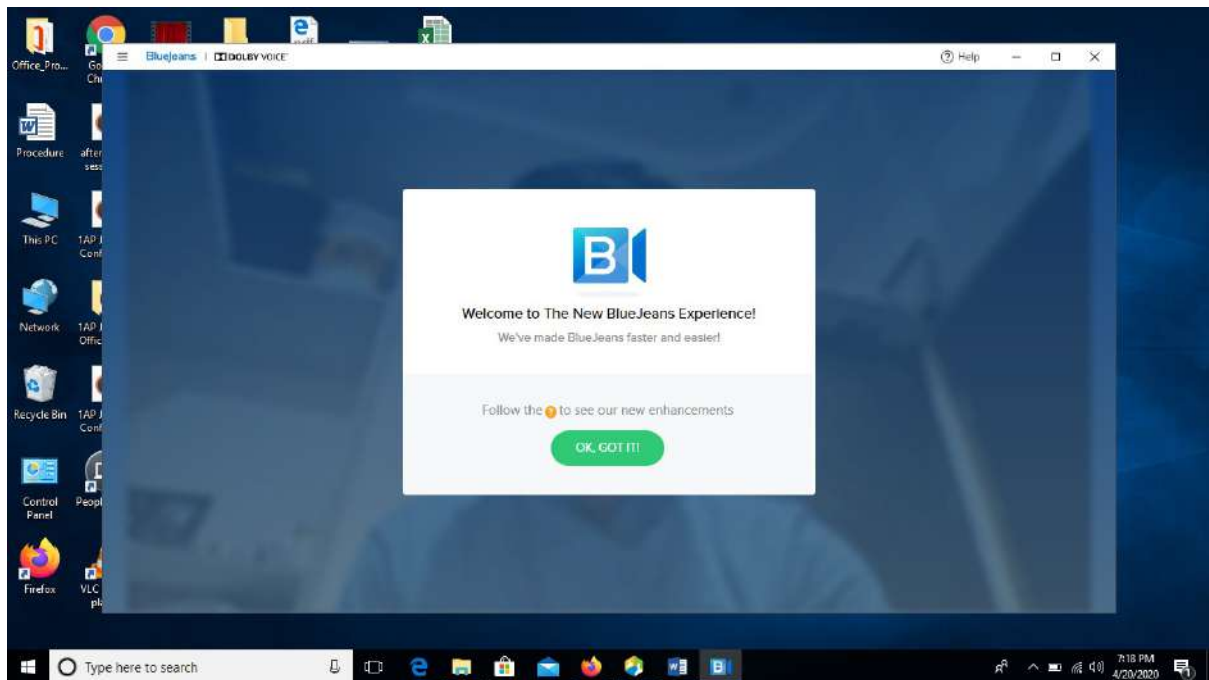
10. If you click on “Bluejeansinstaller”, it will install the application as below:



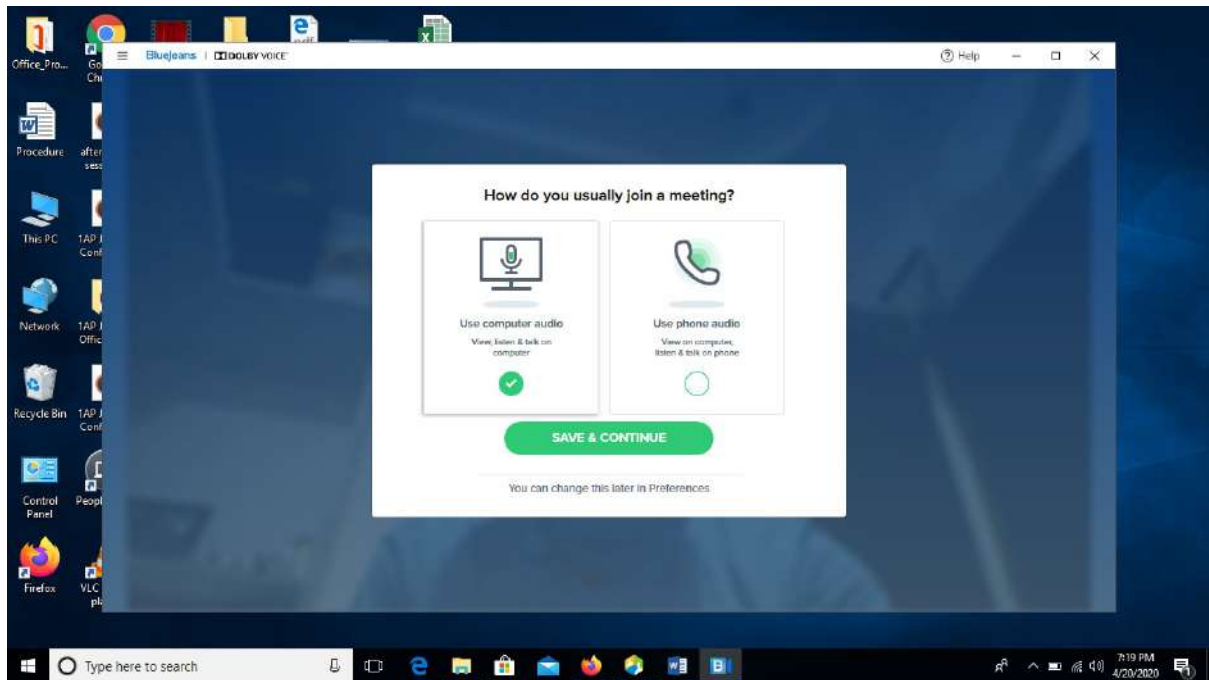
11. After BlueJeans software is installed, you will find BlueJeans app on the Desktop.



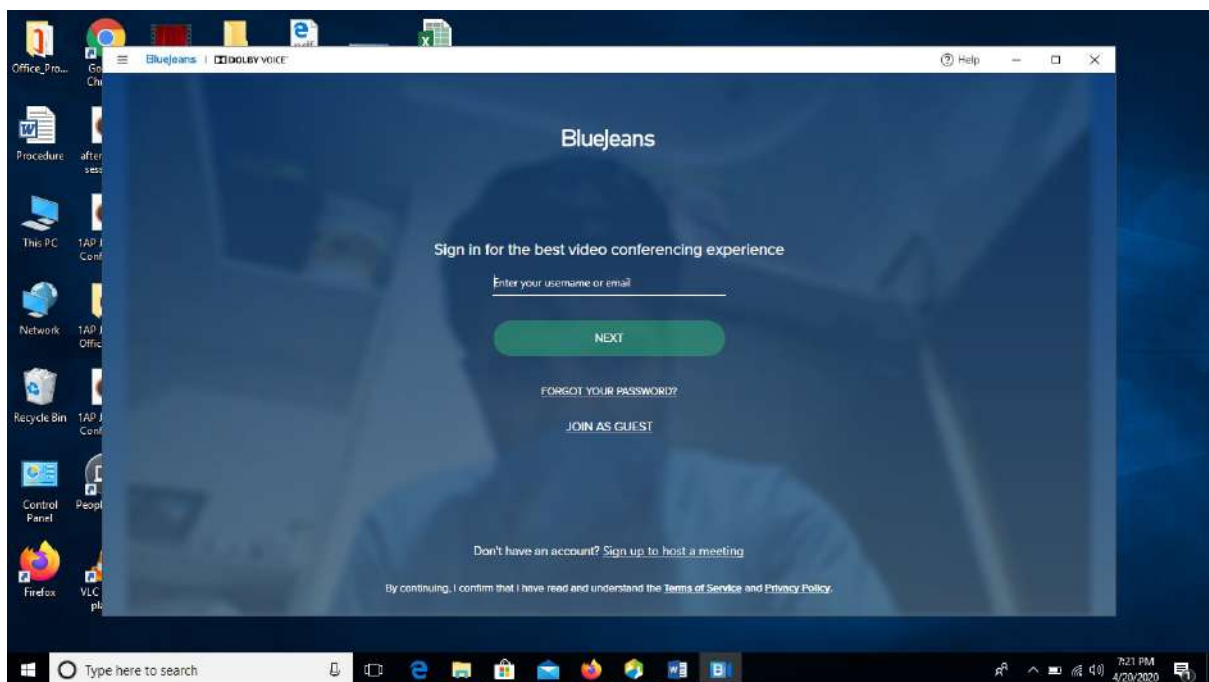
12. Please click on BlueJeans App and click "OK GOT IT"



13. Then you will be asked whether you are joining the meeting with computer audio or phone audio. You have to click on Computer Audio

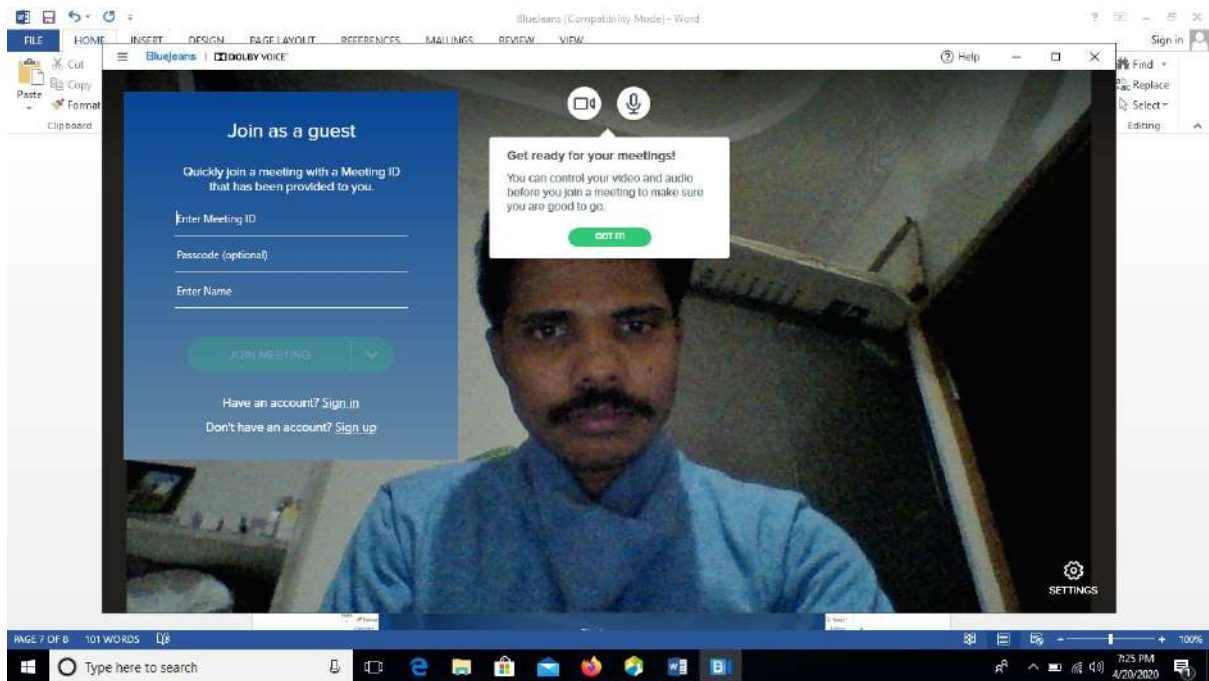


14. Then please click on "JOIN AS GUEST"

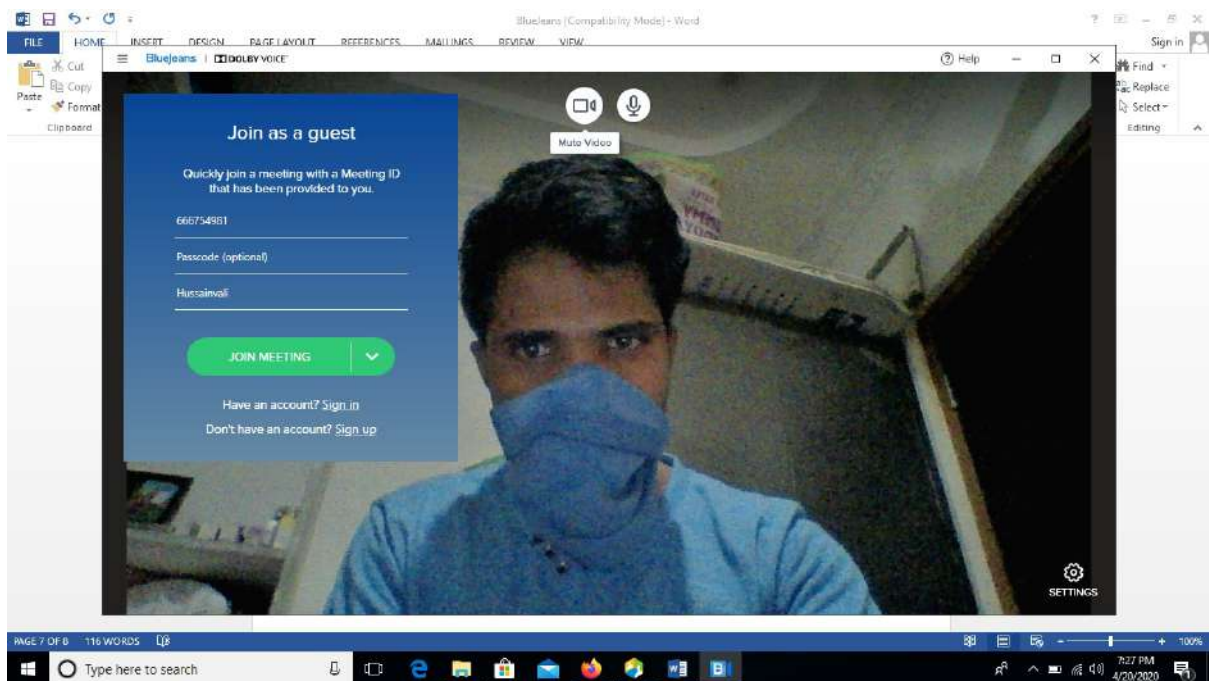




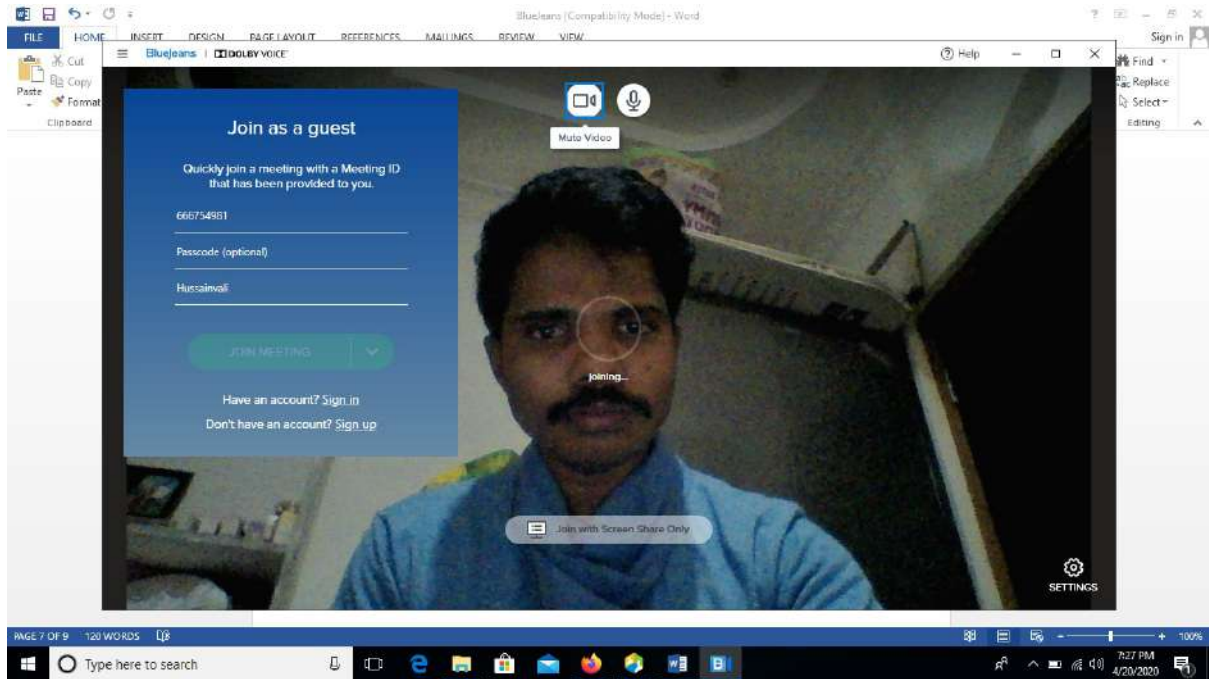
15. Please enter Meeting ID and Name of the learned Advocate/Party-in-person.
