In the light of Endt. No. B/2119/II-15-14/90 Jabalpur dated 07/04/2021, Hon'ble High Court of Madhya Pradesh, Jabalpur and M.P. Rajpatra dated 30/03/2021 containing amendment made in Madhya Pradesh Civil Court (Amendment) Act, 2021.

As per amendment, the words "District Judge" have been substituted by the words "Principal District Judge". The words "District Court" have been substituted by the words "Principal District Court".

As per that amendment, the words "Additional District Judge" have been substituted by the words "District Judge".

As per that amendment, the words "Civil Judge Class-I" have been substituted by the word "Civil Judge, Senior Division" and the word "Civil Judge Class-II" have been substituted by the word "Civil Judge, Junior Division".

So, in pursuance of the direction of Hon'ble High Court, it would be appropriate that, now all the Judges of Hoshangabad District should change their designation according to the above.


