It has come to the notice of the undersigned through letter No. 217 dated 07.07.2020 of Additional District & Sessions Judge cum Nodal Officer (Covid-19), Sub-divisional Civil Court, Dalsinghsarai, that 01 (One) Judicial Officer (Sri Anand Abhishek, ACJM-I cum Sub Judge-I, Dalsinghsarai), 07 (seven) Class-III Staff and 03 (three) Class-IV staff posted at Dalsinghsarai Sub-divisional Civil Court have been found infected from CORONA VIRUS. The matter was apprised to the Hon'ble the Inspecting Judge of Samastipur Judgeship and His Lordship has been pleased to endorse that the courts running on physical mode at Sub-divisional Court Dalsinghsarai shall remain suspended for three days i.e. on 08.07.2020, 09.07.2020 and 10.07.2020 for sanitization work.

The very urgent matter shall be heard through virtual court proceeding from the residence of the Judicial Officer posted there at Dalsinghsarai. Further, the learned Advocates are also requested to participate in the Virtual Court proceedings from their residence or the place they deem fit.

All the Judicial Officers & Staff posted at Sub-divisional Court, Dalsinghsarai are required to keep their cellphones in 'switch on' mode and they shall work from their residential offices/ residences situated at Dalsinghsarai. All staffs who have been found Corona positive are directed to keep themselves in isolation and present in Hospital to re-examine themselves.

The Judicial Officers and Staff who have not gone through test uptill now, they are directed to do the same on urgent basis.

The Judge-in-Charge (Nazarat), Dalsinghsarai is directed to ensure the complete sanitization of the Court premises as well as Courts & Offices.
