This e-bail petition is coming on this day for hearing before me in the presence of Thiru.P.Sankar Guru, Advocate for the petitioners and of Thiru. R.Manoharan, Public Prosecutor for the state on record and on considering the online submissions of either side and on perusal of available records, this court passed the following

ORDER

Petition filed U/s.438 of Cr.P.C., The petitioner/A2 prays to grant him anticipatory bail for the offences punishable U/S. 294(b), 323, 324, 506(ii) IPC in Cr.No.542/2021 of respondent police. The occurrence took place on 08.08.2021.

The learned counsel for the petitioner/A2 would contend that the petitioner and the defacto complainant are adjacent agricultural land lords, that there existed previous enmity between the petitioner and the defacto complainant, due to that enmity, this false case has been foisted against this petitioner, that the injured were discharged from the hospital, that the petitioner is a law abiding citizen and he is ready to abide any condition imposed by the Hon'ble Court, that the petitioner hereby undertakes that he will not abscond and will not tamper any witness and that the petitioner apprehends for arrest and he prays for anticipatory bail.

The learned Public Prosecutor has vehemently objected for anticipatory bail by stating that on 08.08.2021 the accused abused the defacto complainant in filthy language, attacked him and caused grievous injury to him and threatened him with dire consequences, hence the case. However, he has conceded that injured were discharged from the hospital and no previous case is pending against the accused.

Online submission of either side heard. Records perused. Considering the facts that injured have already been discharged from the hospital and no previous case is pending against the accused as stated by the learned Public Prosecutor, that except the offence u/s.506(ii) IPC. other offences are bailable in nature and upon considering the facts and circumstances of the case, this Court inclines to grant anticipatory bail to the petitioner/A2 with condition. Anticipatory Bail is granted to the petitioner/A2 on strict compliance of the following conditions.

1. The petitioner/A2 shall in the event of arrest by the respondent police or his surrender before the learned Additional District Munsif -cum- Judicial Magistrate, Vedsandur within 15 days from the date of this order, be released on bail on executing his own bond for a sum of Rs.10,000/- with two sureties each for a like sum to the satisfaction of the learned Additional District Munsif -cum- Judicial Magistrate, Vedsandur.
2. The petitioner/A2 is directed to appear and sign before the respondent police station daily at 10.00 a.m. for the continuous period of 30 days.
3. The petitioner/A2 shall not directly or indirectly make any inducement threat or promise to any person acquainted with the facts of the case so as to dissuade them from disclosing such facts to the court or to any police officer.
4. The petitioner/ A2 shall make himself available for interrogation by the police officer as and when required.
5. The petitioner/A2 shall not tamper with evidence or witness either during investigation or trial.
6. The petitioner/A2 shall not abscond either during investigation or trial.
7. The petitioner/A2 shall not leave the town without prior permission of the court.
