

## NOTICE FOR EMPANELMENT

The application should strictly be as per the enclosed proforma (computer typing or photocopy of the same can be used) and should accompany the proof of professional experience with special reference to the type of cases which the legal practitioners may prefer to be entrusted with **(for the proof of the same the certificate issued by President/Secretary District Bar Association may be used)**.

It is further brought to notice of all concerned that the empanelment shall be up to 50 (fifty) Advocates and if any Advocate is already empanelled with District Legal Services Authority, Yamuna Nagar and he is desirous of being empaneled in the New Panel, he will have to apply a-fresh, since old Panel of Advocates will be scrapped after Constitution of New Panel.

It is further brought to notice of all concerned that all the Applicants/Advocates should take their unique registration number at the time of depositing their application which will required to be quoted for all further correspondence (if any).

The applicant/Advocate should deposit the application in person and application received through post/courier/e-mail etc. shall not be considered/accepted. The applicant Advocate should clearly mention his/her e-mail ID. The application form shall be deposited at the office of District Legal Services Authority Yamuna Nagar at Jagadhri. **The last date for submission of the Application Form is 06.02.2019 (up to 5.00 P.M).** The selection of the particular advocate to the panel shall be by intraction or by such mode/method as ordered by Ld. Chairman DLSA cum D.&S.J. Yamuna Nagar or by HSLSA Panchkula. The Date of intraction/Schedule of Intraction or other mode/method of selection shall be notified through notice on the notice board of District Legal Services Authority Yamuna Nagar at Jagadhri and Notice to Bar Association Yamuna Nagar at Jagadhri through it's President and separate letter/notice shall not be sent to the applicant Advocate and it shall be his/her responsibility to check the notice boards regularly.
