**ORDER**

Considering the pandemic situation and the lock down announced by the Government, I deem fit to issue further direction regarding compliance of the modified conditional order already imposed by the Court vide ***Suo-Motu CrI. M.P. No.15/2020, dated 15.7.2020***, directing the parties to appear before the concerned court to be modified, if complied with leads to congestion inside the Court Hall and violation of social distance. Further, the petitioners/accused below mentioned have already released on bail/Interim anticipatory bail on condition to furnish surety and other condition on the future date ranging from 26.8.2020 to 9.9.2020. Hence, the condition modified in Column No.VII will stand extend to the period stipulated in Column No.VIII and interim bail/anticipatory bail further extended as per column No.VIII without deviating the condition.
