ESSENTIAL QUALIFICATION FOR THE POST OF LIFT OPERATORS

ESSENTIAL QUALIFICATION FOR THE POST OF SWEEPERS

The applicant should have experience of duties required to be performed by him and the applicant should be able to sign in Hindi or Gurmukhi language as the case may be.
