Eligibility Criteria:**Age:**

For Bench Clerk (Peshkar) : Fresh applicants should have attained an age of 18 years and not more than 40 years as on date of notification. The retired government employees should not be less than 60 years of age on the date of notification and not more than 62 years of age on the date of appointment.

For Group-D : Fresh applicants should have attained an age of 18 years and not more than 40 years as on date of notification. The retired government employees should not be less than 60 years of age on the date of notification and not more than 62 years of age on the date of appointment.

Educational Qualification:

For Bench Clerk (Peshkar) : Applicants must have passed higher secondary examination from a recognized Board. Candidates having knowledge in computer shall be preferred irrespective of whether they are retired court staff or fresh applicants. Candidates applying as fresh applicants having experience in court work shall be preferred.

For Group-D : Applicants must have passed eight standard from any school under any recognized Board

Mode of Examination:

For Bench Clerk (Peshkar) : A written examination carrying 50 marks shall be conducted to assess the knowledge of the candidates on general awareness, English, general mathematics and computer basics. Standard of questions shall be that of class X.

For Group-D : A written examination carrying 50 marks shall be conducted to assess the knowledge of the candidates on English and general mathematics. Standard of questions shall be that of class-VIII.

The final selection list, as may be prepared for giving appointment shall be valid for one year.

How to apply:

Eligible candidates shall have to submit filled up application form in the prescribed format given below as per instruction contained therein along with self-attested photocopies of testimonials. The retired government employees shall submit a Fitness Certificate issued by a registered Medical Practitioner along with their application form. They should also submit a self -attested photocopy of their Pension Payment Order along with the application form.

All candidates must submit two recent passport size photographs - one to be pasted on the top right hand corner of the Application Form and another to be pasted on the Admit card along and a self addressed envelope affixing a stamp of Rs 5/- along with their application form.
