ADVERTISEMNT

Applications are invited from the desirous candidates having requisite qualification and experience along with supporting documents as required under Rule-5 & 6 of the Family Courts (Orissa) Rules 1990, Family Courts (Orissa) amended Rules, 1994 and Family Courts (Court), Rule-2010 for appointment of vacant post of Counsellors in the Court of Judge, Family Court, Sonepur. The Counsellors shall be appointed by the Hon'ble High Court of Orissa.

1. ELIGIBILITY AND QUALIFICATIONS OF THE COUNSELLORS

- a) Be a citizen of India,
- b) Have passed Master Degree in (Social Science preferably in Sociology or psychology),
- c) Have minimum experience of three years in family counselling shall be eligible for appoint as counsellors,
- d) Be able to speak, read and write Odia and have passed test in Odia equivalent to the M.E. standard,
- e) Be of sound health, good physique and free from organic defects or bodily infirmity,
- f) Have not more than one spouse living,

Provided that where such persons are not available, persons above the age of thirty five (35) working in the field of social service and welfare activities and engaged in promoting the welfare of family and child care with a degree in (Social Science preferably in sociology or psychology) shall be eligible for such appointment.

2. FUNCTIONS OF A COUNSELOR :

The function of a counsellor shall be regulated in accordance with terms and conditions laid down in the Family Courts (Orissa) Rules, 1990 and Amendments made there under from time to time.

3. FEE OF A COUNSELLORS :

As per Rule-33 of Family Courts, Orissa Rules-1990, the Counsellor shall be entitled to assisting fee of Rs. 1125/- (Rupees Eleven hundred and twenty five) and Rs. 788/- (Rupees Seven hundred and eighty eight) only respectively per day of actual working as per Law Department Resolution No. 1693 dtd. 15.02.2019. Necessary amendment to Rule 33 of the Family Court (Odisha) Rules, 1990 shall be made subject to final result of Writ Petition (Civil) No. 10344 of 2011.

4. DOCUMENTS REQUIRED

The following list of documents are to be submitted along with the application forms:

- i) Self attested Xerox copies of all the Educational qualification certificates.

- ii) Experience certificate in the field of social service and welfare activities and engagement in promoting the welfare of family and child care preferable working with a recognized institution of social service or social work,
