

OFFICE ORDER:

Vide this office order bearing Endst. No.1392-94 dated 19.01.2019, a committee was constituted for scrutinizing the applications forms submitted by the candidates willing for appointment to the post of Peons advertised in pursuance of directions given by the Hon'ble High Court vide letter No.1145 Spl.E.II/VII.B.3(Hy.) dated 05.12.20018. The Committee consisting of Sh.Ved Parkash Sirohi, Addl. District & Sessions Judge, Panipat, Sh.Sumit Garg, Civil Judge (Senior Division), Panipat and Sh.Vikrant, Civil Judge (Junior Division), Panipat has submitted Minutes of Meeting and the recommendations as made by the Committee as per which, the names of candidates who are overage and underage are liable to be rejected. As per the further recommendations of the Committee, the candidates who have not signed the applications forms and have not furnished photographs and have not filed requisite documents and whose name are mentioned in list as Annexure-A3 to A5 and A7 should be given an opportunity to sign the application forms and to furnish the photographs or documents within 15 days of uploading of said list on the website of the District Courts, Panipat. In view of the recommendations as made by the Committee, the names of candidates as mentioned in list A1 and A2 who are either overage or underage are ordered to be rejected whereas the names of candidates mentioned in the lists Annexure-A3 to 5 and A7 are ordered to be uploaded on the website of the District Courts, Panipat calling upon those candidates to appear and sign the application

forms or furnish photographs or file their requisite documents within 15 days of uploading of the lists. All the eligible candidates will be interviewed for the posts of Peons after uploading the list on the Website of District Courts, Panipat on approval from the Hon'ble High Court.
