



**COURT OF SMALL CAUSES, MUMBAI**

**RESULT OF HIGHER STANDARD DEPARTMENTAL EXAMINATION.**


- 1 The word "Exe." denotes the subject in which the exemption if granted from appearing in examination of that subject as per Rules.
