
1) The above Select/Wait list is valid only for a period of two years from the date of notification i.e. from today.

2) The appointment of the above candidates shall be subject to following conditions.

a) The candidates against whose name # is marked shall have to pass requisite Marathi Typing Test, the candidates against whose name \* is marked shall have to pass requisite English Typing Test and the candidates against whose name #\* are marked shall have to pass requisite both Marathi and English Typing Tests within a period of one year the date of their appointment.

b) The candidates shall be discharged from the service if they fail to clear the requisite tests within a period of one year from the date of appointment.

c) The candidates shall give necessary undertaking to the effect that their appointment is subject to condition as stated above in addition to the usual service condition.
