Sub-Divisional Judicial Magistrate (M), Margherita

Margherita is a census town in Tinsukia district in the Indian state of Assam. The small sub-divisional town has scenic beauty though nothing like a tourism business. The town is surrounded by hills, tea gardens, forest and the Dihing River. It has a beautiful golf course at the foot of the hills and a small stream running through. The name Margherita actually derives from the Italian queen and dates back to the late 19th century as a token appreciation for the Italian Chief Engineer of a rail section Chevalier R Paginini who supervised the construction. Margherita was famous for its collieries much developed by the British. Coal India Ltd is the biggest industry here. Apart from this are Kitply and other small plywood industries and tea gardens. Tata Tea has factories in the locality.

Sadiya is a small town in the Tinsukia district of the North-eastern Indian state of Assam. Sadiya is an assamese name for king of Sutiya tribe. It stands on a grassy plain, nearly surrounded by forested Himalayan mountains, on the right bank of what is locally considered the main stream of the Brahmaputra river. Sadiya is famous for a flower named sotful (the word means "blessing" or a "desert flower"), which is much like Jasmine. Sadiya today serves as one of the district headquarters for Indian Red Cross.
