The Litigating Public, Advocates practising in this Court are hereby informed that in view of the provisions contained in Rule 506 of the Maharashtra Treasury Rules, 1968, Volume-I and Para 742 (27) of Chapter-XL of the High Court Civil Manual and directions issued in High Court Inspection Report-2002 and 2015 of this Court, the deposits not exceeding five rupees unclaimed for one whole account year balance not exceeding five rupees of deposits partly repaid during the year than closing and all balances unclaimed for more than three complete account years will at the close of March in each year be credited to the Government.

In view of the above, the Office has prepared a List of such deposits remain unclaimed for more than three complete Account Year i.e. from 1st April 2012 to 31st March 2015 showing the suit Numbers, Names of the Parties and amount to be credited to the Government by the end of 31st March 2018. The concerned shall approach to the Assistant Registrar, Cash Department of this Court for further action. If no application is made on or before 18th March 2018, the amounts will be lapsed to the Government, as per the provisions contained in Para 742 (27) Chapter XL of Civil Manual.
