**Resolution :** In pursuance to the email dated 18-01-2018 as received from the Dy. Registrar (Judl.)-cum-CPC, Hon'ble the High Court of Tripura, Agartala, sealed quotation were invited from the reputed and experienced service providers/ firms for Comprehensive Annual Maintenance Contract(AMC) for LAN items installed at Udaipur Station under Phase-I and Phase-II of eCourts Project vide No.F.11(39)-DJ/G/UDP/2016-18/2780-81, dated 25-04-2018. A short notice was also published in daily news paper namely Dainik Sambad on 04-05-2018.




