ORDER No. 145 / Admn of 2015

As the Hon'ble Court have been pleased vide letter No. 23954/AD (Misc) Section /PF-IV-23-1993 dated 28.04.2015 to direct that the Select List which was earlier sent by this court Vide letter No. 7170/Admn of 2014 dated 07.11.2014 which was finally approved by the Hon'ble Court's letter No. 8718 dated 12.02.2015 may not be disturbed .

Hence , in pursuance of above-said Hon'ble Court's letter the following candidates as per Select List are hereby selected for the Appointment at Class – IV post in Pay Band of Rs. 5200 – 20200 with Grade Pay Rs 1650/- (for literate) and Grade Pay Rs 1800/- (for qualifying passed) with other allowances admissible from time to time with subject to conditions as follows :-

The appointment is on probation and terminable without assigning any reason or notice .

The candidate is hereby directed to join the post within one month of the issuance of this Appointment Letter failing which the appointment may be canceled .

No T.A. shall be paid for this purpose .

The candidate is further directed to bring the following certificates and declaration in original at the time of joining the post :

1. Certificates showing your age/qualifications etc;
2. Medical Fitness Certificate issued by the C.M.O./Civil Surgeon ;
3. Caste Certificate duly issued by the competent authority (in case of candidates from reserved category) ;
4. Declaration concerning family planning in prescribed proforma ;
5. Declaration regarding dowry ;
6. Declaration to the effect that the candidate has not been convicted in any case by any court of law as well as the candidate has not been dismissed from any Government Service ; and
7. As per direction of the Hon'ble Court the appointment shall be subject to Police Verification .
