Resolution dated 06.02.2017

The Chairman and Two members of this Purchase Committee are present today.

Today is fixed for opening of tenders.

It appears that in all Seven tenders have been received for **Photo Copier (Cannon)** from Das Enterprise- Kolkata, The Rik International- Tamluk, Digital World- Haldia, Ricoh India Ltd.-Haldia, Digitech Computer -Tamluk, Optima Solutions- Kolkata and Unique Computer-Tamluk.

It appears that the price quoted by the **Das Enterprise, 57E, Purna Das Road, Gariahat, Kolkata-29** is the lowest in respect of automatic duplex model and considering the fact that said Enterprise had earlier supplied photocopier machine to the Hon'ble High Court, Calcutta (as is revealed from the copy of document annexed with tender application), the Committee unanimously resolves to accept the tender of Das Enterprise- Kolkata.

It is also resolved in all Five tenders have been received for **various computer equipments as well as Fax machines** from The Rik International- Tamluk, Digital World- Haldia, M/s Comtech- Daspur, Paschim Medinipur, Digitech Computer-Tamluk and Unique Computer-Tamluk.

It appears that the price quoted by the **The Rik International- Tamluk** is the lowest in respect of all **computer equipments including the Fax machines** and considering the fact that earlier also computer articles purchased from said dealer had given good service, the Committee unanimously resolves to accept the tender of Rik International.

It is unanimously decided that following articles should be purchased from **Das Enterprise, 57E, Purna Das Road, Gariahat, Kolkata-29 and The Rik International-Tamluk.**
