**Eligible Persons from whom PLVs can be selected**

- Teachers (including retired teachers);
- Retired Government Servants and Senior Citizens;
- M.S.W. Students and Teachers;
- Anganwadi Workers;
- Doctors/Physicians;
- Students & Law students (till they enroll as lawyers);
- Members of Non-political Service oriented NGOs and Clubs;
- Members of Women Neighborhood Groups, Maithri Sanghams and Other self-help groups including marginalized and vulnerable groups.
- Educated prisoners with good behavior serving long term sentences in prisons;
- Any other person whom the District Legal Service Authority deems fit to be identified as PLVs.

The Selection Committee deserves all powers to use its discretion and shortlist the number of candidates for interview depending upon the number of applications received. The date of interview will be notified later on. The finally selected PLVs will be provided training as per the new module prescribed by the NALSA at the later phase.
