OFFICIAL MEMORANDUM

- Sub: Covid 19 pandemic – functioning of Courts after lockdown – guidelines issued

Pursuant to the Government Order referred to as 3rd above, the Courts in this District will resume regular functions from tomorrow (17.06.2021) onwards, with 25% of staff strength. In the light of the directions contained in the Official Memorandum referred to as 1st above, the following guidelines are issued to regulate the functions of the courts in the coming days, subject to the further directions of the Hon'ble High Court:

1) The Restricted Cause List (RCL) system, as prescribed by the Hon'ble High Court, will be continued for the time being. Every court will prepare the RCL in advance and it will be communicated through e-mail to the Bar Association in the previous day. It will also be published in the website of the District Court, as far as possible.

2) Court proceedings will be conducted through Video Conferencing (Google Meet). The link for the virtual hearing in respect of each Court is enclosed herewith. Matters which are not included in the RCL may also be considered by the court, on mentioning it during the

sitting.

3) If the court is satisfied that physical hearing is unavoidable in a given case, it will fix a time slot for the same and proceed accordingly.

4) Physical filing will be restored from tomorrow (17.06.2021).
The system of online filing will be discontinued.

5) There will be a separate filing box for receiving physical files of the matters which are presented through email during lockdown.

6) All undated cases shall be cleared in CIS within 3 days.
