

ORDER

As per directions contained in order dated 29.04.2020 and letter No. 18/Spl./RG/Misc. dated 08.05.2020 of the Hon'ble High Court of Punjab and Haryana, Chandigarh, the Subordinate Courts in the State of Punjab, Haryana and U.T. Chandigarh will function with the continuation of present arrangement of hearing of cases in view of prevailing situation arising due to outbreak of COVID-19.
