PREAMBLE:-

In view of the Hon'ble High Court of Karnataka, Bengaluru and Government orders as referred above from Sl. No. 1 to 9, granted permission to fill up the existing vacancies of Typists, this office has notified the Notification No. 109/2017 dated 06-03-2017. Accordingly applications were received, thereafter scrutinized the received applications and call letters issued to the eligible candidates calling for qualifying test and interview to the eligible candidates. This office has conducted the qualifying test and after evaluation of answer sheets the selection list issued by this office vide notification referred at Sl. No. 10 with a direction to submit all original documents for due verification from concerned authorities. If any candidate is found having given false information in the application or submitted fake documents his/her selection will be cancelled without giving any notice.
