Applications for filling up 11 (Eleven) vacant posts of Peon etc. (06 General +01 ESM General Category; 02 SC; 01 BC(A) and 01 BC(B) and 02 (two) unreserved vacant posts of Sweeper in the pre-revised pay band of Rs.4440-7440+1300/- Grade Pay and revised pay as per Schedule I Pay Matrix Level DL Cell 1 of Haryana Civil Services (Revised Pay) Rules, 2016, plus usual allowances as admissible, purely on temporary basis in Hisar Sessions Division, are hereby invited from general public. The number of vacancies may increase or decrease.

Educational Qualification:

Candidates, for the post of Peon, should have passed middle standard examination and also possess knowledge of Hindi or Punjabi.

Candidate, for the post of Sweeper, should have desired experience of the duties required to be performed, however, he/she be able to sign in Hindi or Gurmukhi language as the case may be.

Age:

The minimum age limit of a candidate for appointment to the aforesaid posts shall be 18 years and the upper age limit shall be in accordance with the latest instructions of the Haryana Government in this regard to be calculated as on **01.01.2020**.

Provided that where no candidate of reserved category is available then appointment shall be made from general category.

Last date of receipt of applications shall be **28.02.2020 upto 5.00 p.m.** No application, received thereafter shall be entertained in any case.

The incomplete applications and filed without photographs and attested copies of the relevant testimonials/certificates and received after due date or before the date of advertisement shall be out-rightly rejected without any information to the candidates.

Unsigned applications will be deemed to be rejected. The applications for the candidates, who are underage and overage will also be deemed to be rejected. Category mentioned in the application by a candidate once made will not be allowed to be changed.


