4. The supplier must enclose Photostate copies of Shop Registration Certificate, Registration of G.S.T and Pan Card alongwith the quotation.

The quotation shall be selected by the Hon'ble Principal District and Sessions Judge, Nagpur as per quality and lowest rate and accordingly purchase order will be issued to the successful supplier/company. Successful supplier shall have to supply the required material within 7 days from date of purchase order.
