**MEMORANDUM**

In compliance with the **Order dated 29<sup>th</sup> September, 2020** of the Hon'ble High Court of Tripura communicated vide No.F.44(1)(c)-HC/2020/13833 dated **29.09.2020**, taking into account of the present Corona Virus situation, following revised arrangement is being made in the respect of West Tripura Judicial District **for the period w.e.f.01.10.2020 upto 20.11.2020 as follows :-**

1. Filing of all cases, urgent as well as non-urgent, shall be allowed in the District Courts **on all working days during the normal office time** for accepting such matters;
2. On all such freshly filed cases, it would be open for the concerned court to issue notice/ summons, if the same can be done without hearing the parties or the Advocates concerned. On the aforesaid days of the week during the same time, the courts would also accept submission of written statements and written objections;
3. The Courts would take up hearing of all urgent cases including for interim relief as well as for vacating interim relief wherever urgency is shown. In addition, the courts would also take up for hearing applications for maintenance, revision of maintenance orders and execution of maintenance orders under Section 125,127,128 of Cr.PC etc;
4. The Courts may also pass orders or judgments in cases where hearing may have been completed and where no further hearing of the parties or lawyers is necessary;
5. The Courts would entertain and pass appropriate orders on the applications for release of payments in cases, such as Motor Accident Claim Cases, Land Acquisition awards, maintenance orders etc. and accordingly, petitions for disbursement of such payments will be disposed of by the concerned Presiding Officer on their dates of duty.
6. The Courts shall provide certified copies of the orders and judgments to the parties upon applications for such purpose being filed.

11. No person including Officers and employees of the Court during this period shall enter into the Court premises with possible corona virus symptom, unless he has produced any medical clearance certificate in this regard.

12. The Court Inspector, Sadar Police Court will ensure that the persons entering into the Court premise are using face cover/mask and social distance is being maintained properly amongst them.
