In view of order no: 224 dated 28.08.20, passed by the Ld. District Judge, Hooghly, the following arrangement is made for the smooth functioning of this establishment for the period 01.09.20 to 15.09.20:

1. On all working days police station wise put up petition for surrender, return of seized articles and applications u/sec 156(3) of Cr.P.C shall be accepted till 11.30 am as per the schedule below;
2. Filing of petitions u/sec 125 of Cr.P.C, DV Act and Sec 138 of N.I. Act and other complaint cases shall also be accepted on all working days;
3. A maximum number of 15 (fifteen) affidavits shall be taken up each working day;
4. Hearing of interim maintenance or monetary relief petitions under the relevant provisions of Sec 125 of Cr.P.C & the DV Act, hearing of argument can be taken up in presence of both parties as per the diary/cause-list. Pending judgements can also be delivered wherever it is possible;
5. S.A. in complaint cases, charge/plea can also be taken up as per diary/cause-list where parties take steps;
6. During this phase, cases otherwise ready shall be committed to the Ld. Sessions Judge and transfer of case records shall also be made wherever it is possible;
