MEMORANDUM

In compliance with the Order dated 20th July, 2020 of the Hon'ble High Court of Tripura communicated vide No.F.44(1)(c)-HC/2020/10895-10925, dated 20.07.2020, following arrangement is being made to deal with urgent cases such as production of accused person etc. in the respect of West Tripura Judicial District for the period w.e.f.22.07.2020 till 09th August,2020 as follows :-

1. Only on request being made for hearing of urgent cases such as production of accused etc., the concerned Judge, as per roster, would at the time that may be suitable, visit the Court for hearing of the case.
2. In all cases in which dates are already given, concerned Judge of the Court shall adjourned the cases. For such purpose he/she shall not have to call for the records of case or to visit the court. However he shall ensure that the adjourned date of such cases shall be communicated to the concerned Advocate through SMS and such date would also be uploaded in the NJDG as well as in the CIS. System Officer/System Assistant of this office shall make arrangement of the sending of such SMS and uploading of dates in the NJDG as well as CIS accordingly.
3. Sri Anindya Chakraborty, H/C(Sessions), District & Sessions Judge's Court, West Tripura Districts, Agartala is declared as Nodal Officer for making administrative arrangement regarding hearing of all such urgent matters in the Sessions Division of West Tripura Judicial District and also in respect of Civil cases of urgent nature, for communication by Advocates and litigants and also for coordination. 4. Following roster is being made in respect of the Courts of District and Sessions Judge, Addl.District and Sessions Judge, Civil Judge(Sr.Divn)-cum-Asstt. Sessions Judge, West Tripura, Agartala to deal with such urgent matter in criminal side and they will remain at their residence and will attend the court on call, on being requested for hearing of such urgent cases including of production of accused etc. and the Nodal Officer will communicate such request to the concerned Presiding Officer and concerned staff.

5. For any new filing/ pending case of any urgent matter of **Civil nature**, triable by District Judge/ Addl. District Judge, or Civil Judge(Sr.Divn) or Civil Judge(Jr.Divn), Agartala, **Sri Anindya Chakraborty, H/C(Sessions), District & Sessions Judge's Court, West Tripura Districts, Agartala** will be the **Nodal Officer** who will communicate and coordinate with concerned Presiding Officer, as the case may be, for this purpose. It is clarified that for any new filing of Civil nature, the concerned filing Court will deal with the matter initially until transferred to any other court and Presiding Officer of Filing Court will attend the Court on call.

6. **Following officials of the Court of the CJM-cum-Civil Judge(Sr.Divn), West Tripura** shall perform the duty of **Nodal Officer** for the Courts of Chief Judicial Magistrate and Civil Judge(Sr.Divn), Addl. Chief Judicial Magistrate and Civil Judge(Sr.Divn), Judicial Magistrates 1st Class cum Civil Judges(Jr.Divn), Civil Judges(Jr.Divn) cum Judicial Magistrates 1st Class for making administrative arrangement regarding hearing of all


8. The suitable time of hearing of such urgent matter may be determined by the concerned Judge/Presiding officer, as directed by Hon'ble High Court, however the convenient time for video

conferencing with Kendriya Sansodhanagar, Bishalgarh will be from 12PM to 02PM as proposed by them.

9. The entry in the compound would be completely restricted only for the concerned Lawyers or the Police authority and the immediate litigants. Lawyers' colleagues and juniors who are not appearing in the case shall not be allowed entry. Like wise the relatives of the accused or the litigants shall not be permitted except for purpose of providing bail bonds for the accused who are granted bail. The Court Inspector, Sadar Police Court will take proper steps in this regard including close observation and strict compliance of the same.
10. The records of the cases which are either fixed for production of accused from judicial or police custody and the records relating to urgent bail applications like u/s. 438/439 Cr.PC which are fixed for hearing, during this period till 09th August, 2020, of Sessions Division of West Tripura District shall be placed by the concerned Staff member(s), as per roster made separately, before the concerned Judge/Presiding Officer at the time of hearing and they will be the custodian of those records during said period as per the roster made in this regard.
11. Similarly, the related records of the cases which are fixed for production of accused from judicial or police custody, during this period i.e. w.e.f. 21.07.2020 upto 09th August, 2020, in the Magisterial Courts, shall be placed by the concerned Court(s) in the custody of concerned official (Nodal Officers) as mentioned above, who will place the same before the concerned Judge/Presiding Officer at the time of hearing and he will be the custodian of those records during said period as per the roster made separately.
12. To deal with Civil matter, necessary staff will be called by the Nodal Officer(s)/concerned Presiding officer, who shall immediately make them available on call.
13. The Judicial Officers who have already attended duty on 21-07-2020 shall be treated to be an official duty.
