

**OFFICE OF THE PRINCIPAL DISTRICT & SESSIONS JUDGE,
JAMMU**

ORDER

In compliance to the Order No. 334 dated 20.09.2020 of the Hon'ble High Court and to prevent the spread of COVID-19 cases in the Courts located in District Jammu, it is hereby notified that:

1. The work in Courts located in District Jammu shall continue to be governed in terms of Circular No. 06/RG dated 11.07.2020 read with Order No. 183 dated 16.08.2020 of the Hon'ble High Court.

2. All Judicial Officers posted at District Jammu shall conduct hearing of urgent cases only through virtual mode from their respective office chambers or official residences.

3. The contact details, i.e., mobile numbers and emails of Judicial Officers are available at <https://districts.ecourts.gov.in/jammu/judges> and contact details of their respective ministerial staff are available at: <https://districts.ecourts.gov.in/sites/default/files/Details%20of%20court%20staff.pdf>

The ministerial staff shall respond to the lawyers and litigants effectively during court hours, and there shall be proper monitoring of the same by the concerned Judicial Officer. The co-operation of the Ld. Members of Bar is highly solicited.

4. The entry of lawyers and litigants in the Courts located at District Jammu shall remain restricted. The Advocates shall cause their appearance through virtual mode from their residences/offices.

5. The staff (ministerial and class-IV) of all courts shall attend their respective offices on rotational basis which should not be more than 50% strength of staff. The roster shall be maintained by all Courts.

6. Instructions with respect to the fresh urgent cases at District Headquarter, Jammu:
I. Following District & Sessions Judges are nominated for taking up fresh bail/remand at District & Sessions Judges level and other urgent Civil/Criminal matters w.e.f. 21.09.2020 to 30.09.2020 through virtual mode:

(a) Sh. Yashpaul Kotwal, 1st Addl. District & Sessions Judge, Jammu:
From 21.09.2020 to 23.09.2020

(b) Sh. Tahir Khurshid Raina, Addl. District & Sessions Judge, Jammu:
From 24.09.2020 to 27.09.2020

(c) Sh. Sunit Gupta, 3rd Addl. District & Sessions Judge, Jammu:
From 28.09.2020 to 30.09.2020
