Sub:-PUBLIC SERVICES – A.P.J.M.S – Selection of candidates for promotion from the post of Office Subordinates(Category-17) to the posts of Examiner(Category-11), Copyist (Category-12), Driver(Category-14), Record Assistant (Category-15(a), and Process Servers(Category-16) – Empanelment of selected candidates – Orders – Issued.

### **ORDER:-**

The District Judge, Guntur is pleased to pass the following:-

The posts of the Examiner(Category-11), Copyist(Category-12), Driver (Category-14), Record Assistant(Category-15(a), and Process Servers(Category-16) is a non-selection post vide Note under Rule-6 of the Andhra Pradesh Judicial Ministerial and Subordinate Service Rules, 2019.

- 1) Post of **Examiner (category 11)** is to be filled up by promotion of "50% by direct recruitment (2) 50% by promotion of Office subordinate/Attender (category 17)(**Pay Scale-15460-47330**).
- 2) Post of **Copyist (category 12)** is to be filled up by promotion of "50% by direct recruitment (2) 50% by promotion of Office subordinate/Attender (category-17)(**Pay Scale-15460-47330**)
- 3) Post of **Driver-Light vehicle (Category No.14)**, to be filled up by promotion of Office Subordinate Attender (category-17). It is provided in the G.O. that if no eligible candidate is available for promotion, the post may be filled up by way of direct recruitment. (**Pay Scale: 15460-47330**)
- 4) Post of **Record Assistant 15(b)** is to be filled up by promotion of Office Subordinate/Attender (category-17). Provided that if eligible candidates in the category of Office Subordinate/Attender are not available for promotion , then upto 50% posts may be filled up by way of direct recruitment. (**Pay Scale : 15030-46060**)
- 5) Post of **Process Server (Category No.16)** is to be filled up (a) 70% by promotion of Office Subordinate /Attender. (b) 30% by direct recruitment. (**Pay Scale -15460-47330**)

For selection to posts in the above categories by way of promotion, the confidential reports and service registers of the employees eligible from the feeder category of Office Subordinates are called for, received and duly verified.

Since the posts of Examiner(Category-11), Copyist(Category-12), Driver (Category-14), Record Assistant (Category-15(a), and Process Servers (Category-16)

are non-selection posts the seniority among the Office Subordinates is considered for selection of all the above Posts.

The roster points meant for reserved categories are filled up with the eligible seniority of the particular category of candidates after satisfying about their eligibility.

The under mentioned candidates are selected for **Ten(10) posts of Examiners(Category-11)** on the basis of seniority and the rule of reservation in promotions as well as the order of Seniority.

**Roster No.8-ST W is kept as backlog since no eligible candidates of that category within the required qualification for the post is found. Roster Nos.9 to 11 are already filled.**

The under mentioned candidates are selected for fourteen(14) posts of Record Assistants (Category-15(a)) on the basis of seniority and the rule of reservation in promotions as well as the order of Seniority .

As per G.O.Ms. No. 50 dated 23-04-2009 or as per G.O.Ms.No.100 dated 08-08-2013, there is no provision of promotion channel to the Post of the Record Assistant. In this connection, the Hon'ble High Court issued Circular regarding the consideration of promotion to the post of Record Assistant vide under letter in ROC. No. 942/2018-C.1 dated 06-04-2018. But, as per G.O. Ms.No. 76 Law (L.LA & J-Home-Courts. A) Department dated 15-05-2019, it contains the provision of promotion channel to the post of Record Assistant specifically. Therefore, the said Circular of the Hon'ble High Court deemed to be superseded in view of the G.O.Ms.No. 76 Law (L.LA & J-Home-Courts. A) Department dated 15-05-2019 which is communicated by the Hon'ble High Court ROC No.3026/2017-C-1 dated 21-08-2019.

The Pay scale of the Record Assistant viz., **15030-46060** is less than the pay scale of Process Server viz., **15460-47330**. Hence the Record Assistant post may not be considered as promotion post to the Process Server. Hence, Office Subordinates are considered for promotion to the Record Assistant posts.

1. In view of dearth of employees in the District, the Presiding Officers are requested to utilize the services of the above individuals as per office convenience for smooth functioning of administration.
2. The promotions herein above made are purely on temporary basis and they are liable to be reverted at any time without notice and without assigning any reasons.
3. The seniority of the individuals is according to the roster points in their respective categories .
4. The individuals are hereby informed that they shall give **UNDERTAKING** that they are prepared to discharge whatever the duties assigned by the Judicial Officers according to the work exigencies.
5. The performance of the above temporarily promoted employees shall be informed to the District Court by the respective controlling Officers once in three months and the same will be the basis for regularization and declaration of probation if any in respect of the promotion posts.

6. The promotion given above does not absolve the employees from their liability/ accountability in respect of their misconduct if any while functioning in the post prior to promotion.
7. The undertaking letters obtained from the individuals shall be submitted to District Court along with their joining reports by the respective Presiding Officers.
