# The terms and conditions for supply of printer cartridges as follows:-

- The firm which submit the quotations should have HP Authorized Dealer Certificate for supply of Samsung Cartridges along with Original Equipment Manufacture Certificate (OEMC).
- The cartridges should supply on Door Delivery Basis to Tumakuru courts and all Taluka courts of Tumakuru unit within 7 working days from the date of receipt of order from this office and the cost of transportation is to be borne by supplier only.
- The supply of cartridges is on the credit basis and the payment would be made by this office after confirmation of delivery of the goods and receiving funds from the Hon'ble High Court/Government.
- The supplied cartridges should be within the period of Warranty. If the Warranty
  is lapsed cartridges supplied would be returned without making payment at the
  risk of the supplier.

5. If the Prl. District & Sessions Judge, Tumakuru noticed any fault on the cartridges supplied, the cartridges would be returned at the cost of the supplier without giving any notice and the payment would be withheld till the supply of goodquality cartridges.

6. Supply of cartridges are to be genuine and original and should not cross the warranty period. If there is any fault in the product the liability lies on the

supplies and all expenses needs to be borne by the supplier itself.

7. The consolidated billing has to be made in the name of the Prl. District & Sessions Judge, Tumakuru for the cartridges supplied from the supplier. The supplier has to submit the proper endorsement taken (delivery charges) for having delivered the cartridges to the courts for processing of payment.

Supplier should not give room for any complaint on the supplied goods.
