Applications are invited in prescribed format available in Recruitment link in the official Website of the District & Sessions Judge, West Tripura, Agartala (<http://ecourts.gov.in/west-tripura/home>) from the Indian Nationals for filling up the post of P.T.C.W (4 hours) under establishment of District & Sessions Judge, West Tripura, Agartala.



ELIGIBILITY	i) <u>Educational qualification</u> :- Must have passed Class- VIII. ii) <u>Age limit</u> :- Minimum 18 years and maximum 40 years for UR and relaxable by 5 years for ST/SC candidates. (As on 22/10/2020)

The eligible candidate shall be engaged initially for a period of 11 months which may be extended time to time. And as per direction of the Hon'ble High Court of Tripura "The engagement of such part time contingent workers shall be only against the said post and this will not entitle him/them to be appointed as regular employee in the Ministerial establishment of the District Courts nor shall weightage be given to him/them when the posts available under the Tripura District Courts Ministerial Establishment (Recruitment & Condition of Services) Rules 2014 are filled up"

The selection will be made after conducting written examination of multiple choice question judging the basic understanding of the concerned candidate. The examination will be conducted in the vernacular language and shall comprise of 40 (Forty) marks. This would be followed by suitability test to be judged through oral interaction, which will carry 10(ten) marks. There will be no failing marks in either of the two tests.

1. Application in plain paper as per prescribed format addressed to the District & Sessions Judge, West Tripura, Agartala alongwith self-attested copies of relevant Certificates & testimonials [Viz. Educational Qualification Certificate, Caste Certificate and address proof certificate] along with 3 (three) recent self attested passport size colored photographs should reach the Office of the District & Sessions Judge, West Tripura, Agartala on or before 22/10/2020. Applications by hand may be submitted on all working days in between 11.00AM & 4.00 P.M.
2. Incomplete applications will be summarily rejected.
3. Any application by post or hand received after 22/10/2020 shall not be entertained.
