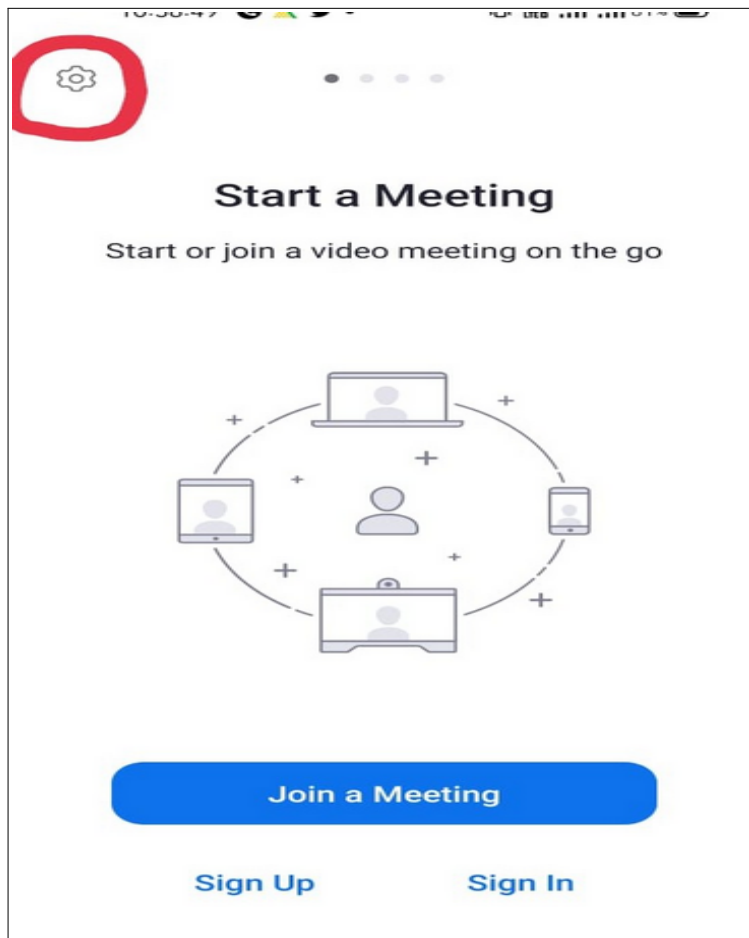

### Steps to connect through ZOOM Link:-

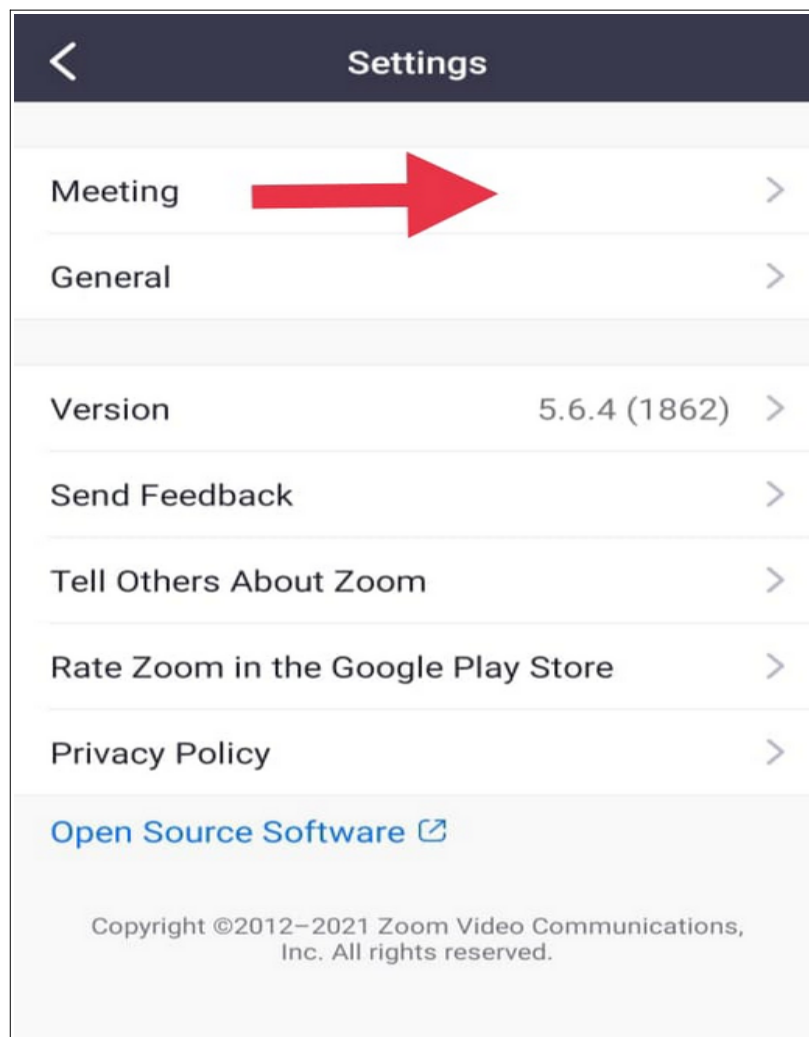
1. First of all install the ZOOM app on your mobile device and follow the below steps in ZOOM app before using. **Note:- These settings are one time settings only.**



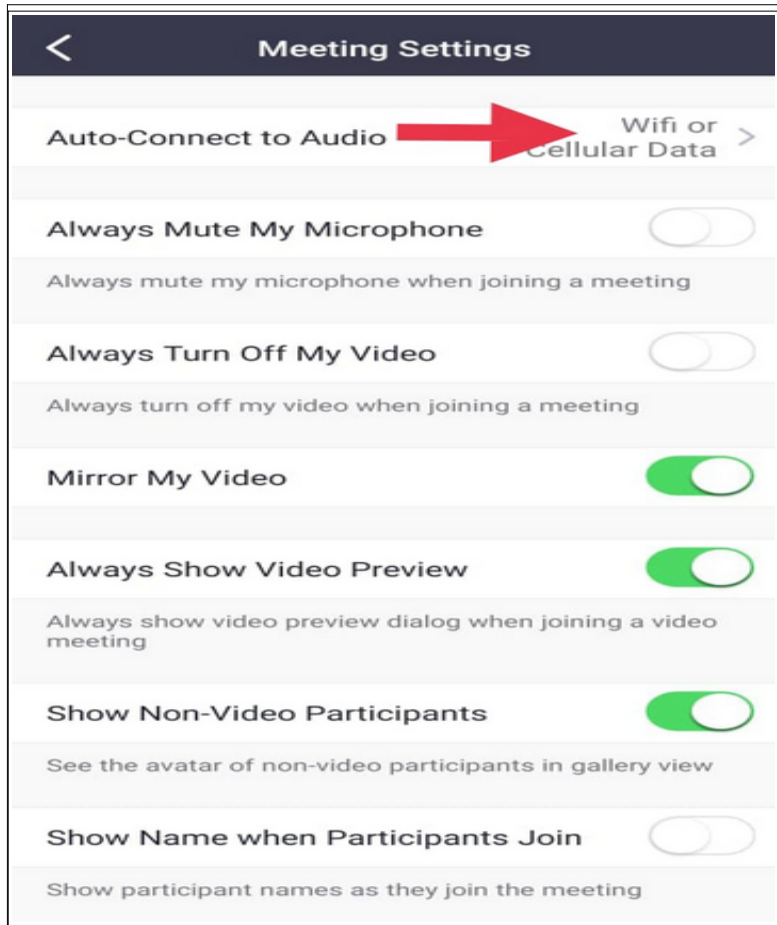
2. Now open ZOOM application and click on **“Gear/Setting Icon”** at top left side as shown below:-



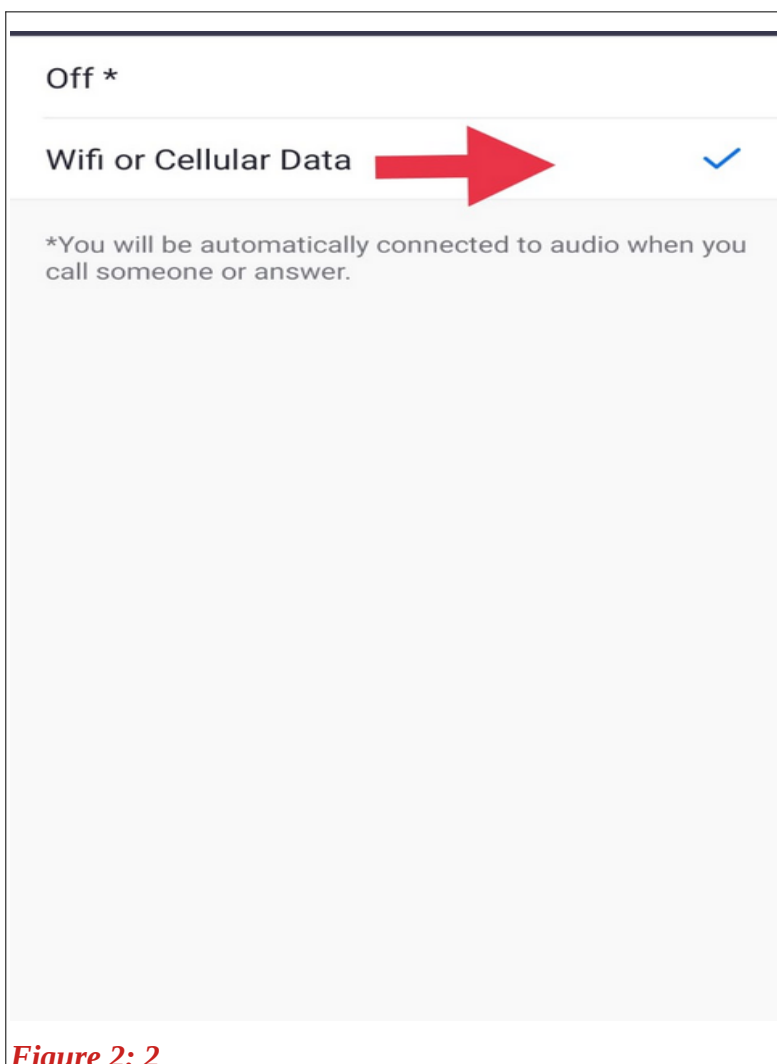
3. After clicking on gear/setting icon new options will open as shown below, now click on first option **“Meeting”**, as shown below :-
