How to connect Court Room through Video Conferencing installed within the Courts working at Bhiwani Sessions Division

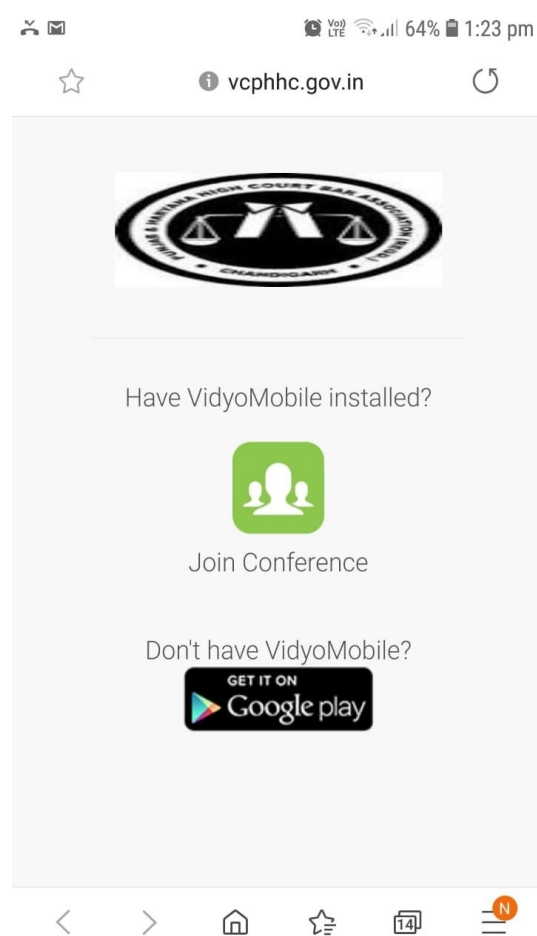

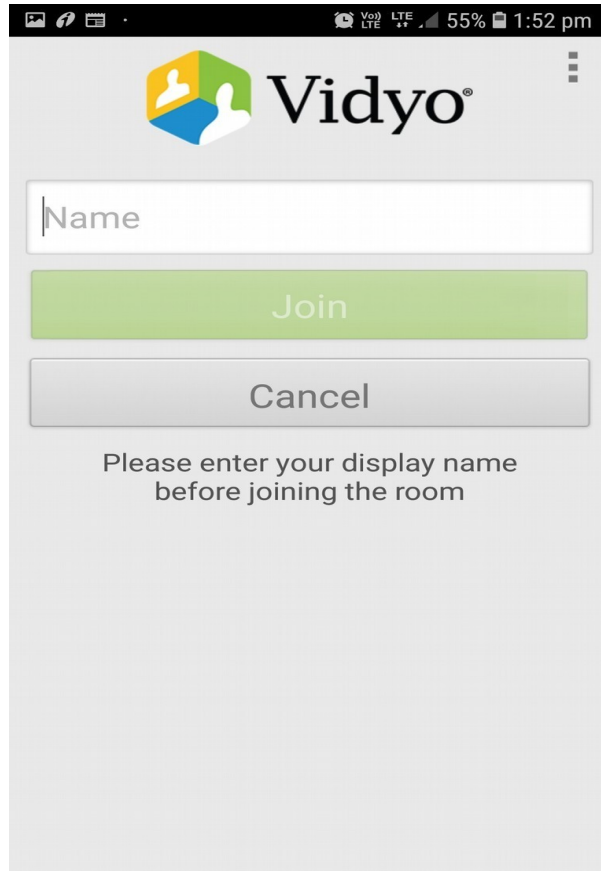
Steps to use VidyoMobile

Follow the below given steps to connect your respective court using Vidyo Mobile app:-

1. Having Contacted the concerned person of this Sessions Division for Video Conferencing connectivity go to website of this Sessions Division i.e. (<https://districts.ecourts.gov.in/bhiwani>) during Court hours and then click on tab **“How to connect Court Room where in case of the concerned Advocate/Parties is fixed for a particular date, through Video Conferencing installed within the Courts working at Bhiwani Sessions Division”** on left side under **“Circular Notices”** Menu and **“Latest Announcements”** Menu on the right side.
2. Click on respective link for VidyoMobile of concerned Court, a new window will open as shown below:-



3. Now click on green button shown in above window and thereafter a new window opens, as shown below:-



4. Now enter your name in “Name” column and click on join button to join concerned Court Room.
5. After that click on Join the Video Conference of concerned Court.

If any Advocate, Public Prosecutor, Investigating Officer or Parties (In person) intend to conduct the Video-Conferencing with the Courts in this Sessions Division he/she has to click on the following link of respective Courts and follow the above said instructions to join the court room.

Upon being joined in the court room, Advocate/Public Prosecutor /Investigating Officer /Parties shall introduce himself/herself to the Hon’ble Court and thereafter shall wait for the instructions from the Hon’ble Court.

On being asked, concerned party may make submissions and on completion of the submissions, concerned person shall at one mute the **mic** from his device. If the Hon’ble Court requires the party to make further submissions he/she will be required to unmute the **mic** of the device and again on completion of the submissions, put the **mic** on mute mode.
