Sub:- TOAL LOCKDOWN - CONVICTS/UNDER TRIAL OFFENDERS - Directions issued by the Hon'ble High Court of A.P. in Taken up W.P.No.8130/2020 dt. 26-3-2020 as an interim measures - Interim bail - release of Convicts/Under Trial Offenders for the offences to which maximum sentence prescribed is not more than (7) years, if they are not second offenders and also not offenders under Section 376 of IPC and POCSO Act, for a period of one month on furnishing adequate bail bonds - nomination of Judicial Magistrates for furnishing/accepting adequate bail bonds to the satisfaction of the Magistrates - orders - Issued.

**ORDER :**



The Honourable High Court of Andhra Pradesh while passing orders in the Taken Up Writ Petition No. 8130/2020 dt. 26-3-2020, issued certain directions as interim measures for the release of Convicts/Under Trial offenders for the offences to which maximum sentence prescribed is not more than (7) years, if they are not second offenders and also not offenders under Section 376 of IPC and POCSO Act, for a period of one month on interim bail, on furnishing adequate bail bonds and for the said purpose of bail bond, and the Principal District & Sessions Judges to assign the Judicial Magistrate to reach the District Jails on being asked by the Superintendent of the Central Jail of his area, for furnishing/accepting adequate bail bonds to the satisfaction of the Magistrate, for their release to a limited period.

In pursuance of the above direction, the following Magistrates are hereby nominated to visit the Sub jails in their respective stations.

S.No.	Station	Name of the officer nominated
1.	Anakapalli	II Addl. Junior Civil Judge, Anakapalli
2.	Yellamanchili	Prl. Junior Civil Judge, Yellamanchili
3.	Narasipatnam	Addl. Junior Civil Judge, Narasipatnam
4.	Chintapalli	Addl. Junior Civil Judge, Narasipatnam (FAC) JFCM, Chintapalli
5.	Chodavaram	Additional Junior Civil Judge, Chodavaram

The above nominated Judicial officers shall visit the respective Sub-Jails on being requisitioned by the Jail authorities for furnishing/accepting adequate bail bonds to their satisfaction, for the release of Convicts/Under Trial offenders for the offences to which maximum sentence prescribed is not more than (7) years, if they are not second offenders and also not offenders under Section 376 of IPC and POCSO Act to a limited period of one month on interim bail, by obtaining undertaking from them for having quarantine for 14 days at their home under the surveillance of the Doctor with the help of the Police.
