

**Notification No. 4384 - G.S.**


**The following list of days to be observed in the year 2020 as holidays in the Subordinate Civil Courts in West Bengal has been prepared by the High Court at Calcutta in exercise of the powers vested in it by Section 15 of Act II of 1887.**

- Note 1 :** Public Holiday on account of Easter Saturday (April 11<sup>th</sup>) falls on Second Saturday.
- Note 2 :** Public Holiday on account of Republic Day (January 26<sup>th</sup>) falls on Sunday.
- Note 3 :** Holidays on account of Muslim Festivals viz. Id-ul-Fitre, Id-uz-Zoha (Bakrid) and Muharram will be declared later on, depending on visibility of the moon.
- Note 4 :** Sectional Holiday on account of Sab-e-Barat (April 9<sup>th</sup>) falls on Thursday.
- Note 5 :** Sectional holiday on account of Mahabir Jayanti (April 6<sup>th</sup>) may be granted, when possible, to the Jain employees. Sectional holiday on account of Baisakhi (April 13<sup>th</sup>) coincides with the Chaitra Sankranti falls on Monday. Sectional Holiday on account of Buddha Purnima (7<sup>th</sup> May) falls on Thursday may be granted for the Buddhist employees. In West Bengal, all Officials, Suitors and Witnesses who profess the Brahma faith may be granted, when possible, 3 (three) days' holidays on account of Maghotsav one day before and one day after that date.
- Note 6 :** The Court and Offices of the Judgeship of Darjeeling shall remain closed on 13.07.2020 (Monday) on account of the birth day of the Nepali Poet Bhanu Bhakta.
- Note 7 :** All the District Judges in West Bengal, Chief Judges of the City Civil Court at Calcutta, City Sessions Court, Calcutta and the Chief Metropolitan Magistrate, Calcutta are hereby empowered to declare local holidays not exceeding two days in a year in a district and/or Sub-Divisions according to the prevalent customs in consultation with the local Bar Associations.
- Note 8 :** All 2<sup>nd</sup> and 4<sup>th</sup> Saturdays of the months have been declared as holidays for the Subordinate Civil & Criminal Courts in West Bengal Vide F.C. Resolution dated 06.08.92.
- Note 9 :** The Courts in the District of Darjeeling & Kalimpong, excepting the Courts in Siliguri Sub-Division under Darjeeling Judgeship shall have no Summer Vacation unlike that of all other Districts of West Bengal.
- Note 10 :** In the districts of Darjeeling & Kalimpong, the Courts excepting the Courts in Siliguri Sub-Division of Darjeeling shall be closed for Durga Puja to Laxmi Puja during the Executive holidays from October 22<sup>nd</sup> to October 30<sup>th</sup> and Bhatridwitiya (November 16<sup>th</sup>). The Courts in the districts of Darjeeling & Kalimpong shall also be closed for Annual Vacation for the period from the 2<sup>nd</sup> January to 26<sup>th</sup> January and 25<sup>th</sup> December to 31<sup>st</sup> December, 2020 excepting the Courts in the Siliguri Sub-Division in the District of Darjeeling which shall be closed for Annual Vacation as in the District of Jalpaiguri.
