**ORDER**

Considering the pandemic situation and the lock down announced by the Government, I deem fit to issue further direction regarding compliance of the conditional order already imposed by the Court, directing the parties to appear before the concerned court to be modified, if complied with leads to congestion inside the Court Hall and violation of social distance. Further, the petitioners/accused below mentioned have already released on bail or granted Interim bail or anticipatory bail on condition to furnish surety and other condition on the future date ranging from 17.6.2020 to 21.7.2020. Hence, the condition modified in Column No.VI will stand extend to the period stipulated in Column No.VII and interim bail/anticipatory bail further extended as per column No.VII without deviating the condition.
