6. Rates should be quoted taking into account the description, specification etc. appended below .
7. Rates quoted should be inclusive of all applicable charges, taxes, duties, levies and GST etc. if any.
8. The intending participants shall have to submit Trade Licence, PAN etc.
9. Conditional quotations will not be considered.
10. The participants shall have to mention details of guarantee/warranty etc. of the machine in the quotation.
11. The participants shall have to submit details of Bank Accounts (Account No, IFS Code, Name of the Bank and its address) in the quotation.

- Memory (RAM) – 320MB
- Zoom Range – 25% - 400%
