The interested parties/tenderers are requested to furnish earnest money to the extent of 2% of the total tendered amount in the form of a bank guarantee or bank draft of the nationalized or recognized banking institution in favour of the District & Sessions Judge, Bilaspur, H.P. payable/drawn at Bilaspur. Any quotation received without earnest money shall be liable to be rejected straightway. However, the earnest money received from the unsuccessful tenderers shall be released to them without interest within a reasonable period.
2. The successful tenderer shall also have to furnish performance security to the extent of five (5) percent of the total consideration amount of the contract. The terms and conditions for making the payment shall be regulated as per mandate of Rule 108 of the H.P.F.R., 2009, an extract whereof is annexed as **Annexure – ‘A’**.

The tenderer(s) should be an authorized service provider with sufficient backup of Spare Parts, having an authorization Certificate in this effect from OEM, based anywhere in and around Himachal Pradesh, having at least one resident engineer at Bilaspur should be already providing such maintenance services to at least 3 or more Departments of the State Governments and in a position to provide maintenance services within 1 or 2 days through a centralized system of call logging”.
